Subject : Complaint against bar named Beer Republic2 Siliguri and Mr. Keerat Singh

Respected Sir,

With due respect and humble submission, I Dipshika Gautam D/O of Lt. Hem Kumar Gautam and my friend Yumei Tamang, D/O Mr. Pemba Tamang residing at Salbari Hart Bazaar, PS Pradhan Nagar, Siliguri, District Darjeeling, would like to state that :

- We entered Beer Republic2 at around 12:00 am and were allowed entry.
- There was a verbal spat between the lady bouncer and I where a lot of coarse and racist words, which questioned our character were used against me and my friend, which led to a scuffle between my friend and the female bouncer, Miss Pushpa Sharma.
- Without any provocation Mr. Keerat Singh who also happens to be the owner of the club started physically assaulting my friend and choked her with a clear intention of hurting her and outraged the modesty of a woman.
- They had also passed comments like "We beat up Nepali people like you every now and then" "you people don't belong here" type of attitude and showed a racist behavior.
- The male bouncers, especially Mr. Amit Singh instead of stopping the fight joined the melee and started beating us even though we were outnumbered and physically inferior to them. He targeted our male friends who were actually trying to settle the dispute. During the dispute I was also physically harmed by the Male Bouncers.
- Please note that we would also like to state that we had paid our bill at around 1:46 am as evidenced by the print out of screenshot we have attached.
- We were intimidated and scared by the whole incident and mentally disturbed as a result of which we did not file any FIR or general diary. Our Valuables were also damaged.
- We also reached out to him seeking a simple apology to which he did not respond well.
- On 7th of August at 12:03 am I received a text message from Mr. Keerat Singh via mobile number 9831443811. The transcript of which is as follows "You will pay for what you have done, God bless you, I will never forget" to which I replied is that a threat?" to which he replied "Just a safety call, God bless you"
- This has ultimately forced us to take this matter up with your kind self as we feel that we may be in danger from criminal elements of the society.

We are common people who are working hard each day to achieve our dreams and have no malafied intention towards the society as we are just at the early stages of our career.

We fear that our lives may be in danger by the criminal elements of the society and we seek your necessary action you deem fit to prevent any wrong doing and safeguard the interest of the society. Seeking your humble cooperation
