Subject : Lodging FIR against accused person for violence under Siliguri Sub-Urban Division

Dear Sir,

With reference to the above captioned subject matter the undersigned likes to inform you that on 07.08.2022 at 1:30 AM a complaint was received from 2 mobile phone no(8617895046 & 7430920600) regarding fassing on the Khaprauli 11KV feeder of NBU 132/33/11KV substation at Sadhan More, Chittanya Pur, New Rangia. After received of complaint HT mobile van staff of NBU 132/33/11KV substation reached the spot immediately. The mobile van staff found out that the fassing was due to tree branch which fall on the feeder line and they cleared it. Subsequently the feeder line had been restored at around 1:15 AM.

After restoring the line when the HT mobile van staff get the mobile van ready for return to the substation then 4 people(Name : Bapi Singh, Rahul and 2 others) came in 1-10 car and allegedly blocked the moble van and started abused them and later started a fight with the mobile van staff without any reason. A staff member's (Monoranjan Singha) eyes were heavily damaged and rest of the staff members were also got seriously injured. After that incident mobile van staff admitted Monoranjan Singha to the North Bengal Medical College And Hospital for treatment.

It may be stated here that such kind of reckless activity of that 4 people is intolerable as we are involved in emergency duty. We have to maintain steady power flow and whenever there is a breakdown, we restore the line within minimum time. If this type of incident happened to our HT mobile van staff then it is very difficult for us to work efficiently.

In view of the above you are requested to lodge a FIR against the accused persons(Namely Bapi Singh, Rahul and 2 others). Thanking you.
