Sir,


With due respect and humble submission, I Smt. Rosy Mukherjee, W/o Sri Deepen Mukherjee of
38, Zakhir Hussain Road, Cedar Cottage, P.O.P.S. & District Darjeeling would like to state the
following facts:

1. That I had purchased a piece and parcel of land measuring more or less 0.812 acres, being LR Khatian no. 338, Plot no. 128(RS), 486(LR) Mouza Sishabari, under Pradhan Nagar Police Station, Siliguri, from one Smt. Kala Sinha Giri, W/o Sri Jeetu Giri of Dumaram Busti, Kurseong through one Smt. Gita Mohanta Giri, W/o Sri Yogesh Mohanta Giri of Champasari, P.S. Pradhan Nagar, Siliguri in the year 2017.
2. That the main brokers of finalising the deal of the said land were Mr. Ramesh Biswakarma of Mallaguri who claims to be a teacher at Champasari area and Sri Jiwan Sunar of Milanmore.
3. That without any prior notice or information, the above named persons has sold the above mentioned land to another person with the intention fraud and cheat on me.
4. That I had also given information to the Pradhan Nagar Police on 24.01.2021 regarding the fraud done by Mr. Ramesh Biswakarma and Sri Jiwan Sunar (Copy enclosed).
5. That I have paid a sum of Rs. 5,00,000/- (Rupees Five Lakh) only to Sri Ramesh Biswakarma and Sri Jiwan Sunar and Rs. 1,20,000/- (Rupees One Lakh Twenty Thousand) only to Smt. Gita Mohanta Giri beside the Rs. 1,00000/- (Rupees One Lakh) only for the purpose of registration.
6. That the above mentioned people made me visit again and again with matters pertaining to the said land wherein I had to spend a huge amount of my hard earned money for frequent travels and visits, to and from my house in Darjeeling.
7. That I even made several requests to the above named persons to refund my money in the present rate of the said land but they make lame excuses time and again and dismiss the matter nonchalantly.
8. That the intentions of the above named people are purely malafide, fraudulent, deceitful and they have simply stolen my money by cheating me with this ruse by not delivering the said land to me and have not refunded me the amount as well.

Considering the above facts and circumstances, I most respectfully request to your goodself to initiate appropriate and extremely strict legal actions against the above named persons and provide justice to me at the earliest for which I shall remain grateful to you.
