I, PSI Rantu Haldar of Bhaktinagar PS under Siliguri Police Commissionerate do hereby lodged this written complaint against above noted accused person to the effect that on 13.08.2022 while performing special raid duty under Bhaktinagar PS area vide BKN PS GDE No. 669 Dated 13.08.2022 at about 13.35 Hrs I received source information that the above noted person have possessed huge amount of Liquor at Salugara Bázar under Bhakti Nagar PS for the purpose of selling the same to local customers. Accordingly the information shared before you and as per your kind direction I along with Constable C/1431 Dilip Barman, CVF/ 935 Biplab Roy headed towards Salugara Bazar to verify the veracity of the information. At about 13.55 hrs we reached at Salugara Bazar and as shown and being identified by the source held raid at the above noted person shop and apprehended one person who disclosed his identity as noted above. Further maintaining his decency and observing all formalities searched him and recovered huge amount of above noted seized liquor from his possession. On demand he could not produce any valid documents/licence in respect of the recovered liquor. On enquiry the apprehended person admitted his guilt and confessed that he have possessed above noted liquor at his shop for the purpose of selling to his designed customers. He also stated that he have been doing this illegally since long without any valid licence or Documents for their wrongful gain. Accordingly, I prepared seizure list of the above noted articles in presence of witnesses duly sign by the accused as well as witnesses. The seizure made between 14.30Hrs to 14.55 Hrs. As he has violated the rules and norms of Bengal Excise Act hence I arrested the apprehended accused person u/s 41 Cr.P.C appraising him the ground of arrest.

l, therefore pray before your kind honour that a specific case may kindly be registered against accused person namely 1.Mangal Munda (M-37years)S/O- Binu Munda of Bidhan Nagar ,Situvhita, PS-Phansidewa, Dist-Darjeeling under proper section of law and arrange for its investigation.
