In producing here with the one arrested accused person namely Kamai Sarkar (53) sto late Ram Chandra Sarkar of South Bharat Nagar, Fuleshwari ward no 24 PS. Siliguri Dist. Darjeeting along with Eleven (11) bottles of Himalayan Gold 60 up country spirit each bottle containing 600 ml. (Total market value RS/- 120 X 11 = Rs1320/-)

I PSI Sumit Rawat of Siliguri PS under Siliguri Police Commissionerate do here by lodge a written complaint against the arrested accused person namely Kamal Sarkar (53) s/o late Ram Chandra Sarkar of South Bharat Nagar, Fuleshwari ward no 24 PS- Siliguri Dist- Darjeeling to the effect that on 13/08/2022 at about 21.40 hrs I received a source information from Fuleshwari bazar, ward no 24 under Siliguri PS that one person namely Kamal Sarkar of Fuleshwari ward no 24 under Siliguri PS, he is selling huge quantity of Equor illegally in his grocery shop to his design customers since long, for his wrongful gain. The fact was diarized in General Diary vide Siliguri PS GDE no 832 dated 13/08/2022, about the information share with I/C Siliguri PS and as per his kind direction, I along with ASI Siben Sarkar, ASI Debasish Das, CV/263 Prasenjit Dey proceeded to the P.O to work out the source information. At about 22.55 hrs I along with force reached at Fuleshwari Bazar under Siliguri PS, on being shown by the source our police team held raid in the shop of Kamal Sarkar and detained the said person, and recovered Eleven (11) sealed bottles of Himalayan gold 60 up country spirit each bottle containing 600 ml. On interrogation he disclosed his identity as Kamal Sarkar (53) s/o late Ram Chandra Sarkar of South Bharat Nagar, Fuleshwari ward no 24 PS- Siliguri Dist- Darjeeling and he admitted that he sell the same to his design customers since long for his wrongful gain. On demand he failed to produce any valid documents or license in r/o said liquor, accordingly I seized the same viz; Eleven (11) sealed bottles of Himalayan Gold 60 up country spirit each bottle containing 600 ml. (Total market value RS/- 120 X 11 = Rs1320/-) from the possession of Kamal Sarkar (52) s/o late Ram Chandra Sarkar of South Bharat Nagar. Fuleshwari ward no 24 PS- Siliguri Dist- Darjeeling (seizure and labelled was made between 22.15 hrs to 22.40 hrs) in presence of witnesses duly sign by the accused as well as witnesses. As he violated the rules and norms of Bengal Excise Act, as such I arrested him u/s 41 Cr.P.C appraise him ground of arrest and issued arrest memo in presence of witnesses.
