SUBJECT :- First Information Report (FIR) against Nandu Prasad, Abhishek Prasad, Rahul Prasad & Smt. Chandrawati Devi

Respected Sir,

I, Mandeep Gupta, S/o. Mr. Arun Kumar Gupta, R/o. Flat C-4, Siddhi Residency, Upper Bhanunagar, Near Lions Eye Hospital, P.O. Sevoke Road & P.S. Bhaktinagar, District Jalpaiguri, Pin-734001, West Bengal would like to draw your kind attention in the following facts:-

1. That my brother namely Mr. Praveen Gupta, S/o. Sri Arun Kumar Gupta, R/o. Flat C-4, Siddhi Residency, Upper Bhanunagar, Near Lions Eye Hospital, P.O. Sevoke Road & P.S. Bhaktinagar, District Jalpaiguri, Pin-734001, West Bengal got married to Smt. Deepika Prasad, D/o. Sri Nandu Prasad, R/o. Hemanta Basu Colony, Ward No. 4, P.O. & P.S. Siliguri, District Darjeeling, West Bengal on 22-04-2021.

2. That after marriage my brother & his wife cohabited together at our flat at Flat C-4, Siddhi Residency, Upper Bhanunagar, Near Lions Eye Hospital, P.O. Sevoke Road & P.S. Bhaktinagar, District Jalpaiguri, Pin-734001, West Bengal.

3. That Smt. Deepika Prasad left for her parental house in the month of June 2022.

4. That today i.e. on 13-08-2022 at about 3.00 P.M. Smt. Deepika Prasad along with her Paternal Aunty Smt. Indu Devi came to our Flat and started shouting and miss-behaving with my brother and aged parents. My brother and all my family members tried our best to make Smt. Deepika Prasad understand that being a residence of a society please stop shouting but Smt. Deepika Prasad & her Paternal Aunty Smt. Indu Devi were unstoppable. They even physically assaulted my aged parents. Finding no other option my brother called his Father-In-Law Sri Nandu Prasad in his mobile number but he didn't receive the call and hence my brother and my father went to the house of Sri Nandu Prasad to inform him about act of her daughter & sister.

5. That after my brother and my father reached at the house of Sri Nandu Prasad at Hemanta Basu Colony, Ward No. 4, P.O. & P.S. Siliguri, District Darjeeling, West Bengal he called them inside the house and locked the main entrance. As soon as they locked the entrance Nandu Prasad along with his son namely Abhishek Prasad, wife Smt. Chandrawati Devi & one relative Rahul Prasad catch hold of my brother and hit him from back. My father is an aged persons aged about 64 years and when my father tried to

save my brother, Abhishek Prasad & Rahul Prasad hit my father in his face and chest due to which my father fell down and could not retaliate. Nandu Prasad, Abhishek Prasad, Smt. Chandrawati Devi & Rahul Prasad continuously physically assaulted my brother with hits, blow & kicks. Due to the said assault my brother and father sustained injuries. My brother anyhow managed and took my father out of their house and called me over my mobile phone. Hearing about the incident I went at the spot and took my father and brother with me and admitted them at Siliguri Hospital for treatment. They have been admitted at Siliguri Hospital and are undergoing treatment. My brother informed me that the intension of Nandu Prasad, Abhishek Prasad, Smt. Chandrawati Devi & Rahul Prasad was to kill them.

6. Smt. Deepika Prasad and her Paternal Aunt Smt. Indu Devi are at present at our Flat.
7. That it has become their regular act and finding no other option I came before you for justice.

It is requested before you in folded hand to kindly look into the matter and take necessary action against the persons involved in the said illegal act.
