He become nervous and admitted his guilt before us and stated that he sell the same in the customer since long for his wrongful gain. Nirmal Gupta of Barivasa, Near Avinandan Sangha, PS - NJP, Dist - Jalpaiguri and 2) Abhijit Majumder S/o. Lt. Ashim Majumder of Business colony, Ambari-Falakata, PO. Kamarvita, PS. NJP, Dist-Jalpaiguri after preparing proper seizure list and took signature of the accused person and witnesses. The seizure was made in between 18:20 hrs to 18:30hrs.
