Sir,

In producing herewith one arrested accused person namely Somnath Gupta (23yrs), S/o - Lt. Nirmal Gupta of Barivasa, Near Avinandan Sangha, PS - NJP, Dist - Jalpaiguri along with the following seized articles as per proper seizure list:

1. 12 (Twelve) sealed bottles of Tuborg Premium beer, each bottle containing 650 ML.
2. One Nylon Bag.

1. ASI. Rabi Tamang of Ambari Falakata out post under NJP PS/SPC lodged a written complainant against the above noted accused person to the effect that today on 13.08.2022 at 17:35 hrs received a source information from Krishna Nagar Colony under Ambari-Falakata Out Post that the above noted person has gathered huge amount of liquor illegally for selling the same in the customer for his wrongful gain. This refers to Ambari Falakata Out Post GDE 452, dated 13.08.2022. I informed to O/C Ambari Falakata out post about the information. As per his kind instruction I along with, (1) NVF/-043 Ranjan Das and (2) NVF-068 Amit Roy both of Ambari-Falakata OP, Under NJP PS/SPC proceeds to Krishna Nagar Colony area to work out the information. At 17:55hrs we reached at the spot, sometimes after being identified by the source our police party held raid at the local area, situated at Krishna Nagar Colony and recovered the above noted articles from the possession of accused person namely Somnath Gupta (23yrs), S/o - Lt. Nirmal Gupta of Barivasa, Near Avinandan Sangha, PS - NJP, Dist - Jalpaiguri. On demand he could not produce any valid license/documents in support of said liquor. He become nervous and admitted his guilt before us and stated that he sell the same in the customer since long for his wrongful gain. Accordingly I seized the above noted articles from the possession of above noted accused person in presence of witnesses namely 1) Maya Gupta W/o. Lt. Nirmal Gupta of Barivasa, Near Avinandan Sangha, PS - NJP, Dist - Jalpaiguri and 2) Abhijit Majumder S/o. Lt. Ashim Majumder of Business colony, Ambari-Falakata, PO. Kamarvita, PS. NJP, Dist-Jalpaiguri after preparing proper seizure list and took signature of the accused person and witnesses. The seizure was made in between 18:20 hrs to 18:30hrs. Then I arrested the said noted accused person u/s 41 Cr.P.C. and issued him Memo of arrest appraising the ground of arrest in presence of witnesses.

I therefore request you that a specific case may kindly be started against the accused person namely Somnath Gupta (23yrs), S/o - Lt. Nirmal Gupta of Barivasa, Near Avinandan Sangha, PS - NJP, Dist - Jalpaiguri under proper section of law.
