No. WB/73/E /9356 van loaded with River bed materials standing at Balasan River Bed, Fulbari Patan ghat without any valid documents. Accordingly, diarized the fact in General Diary vide Matigara PS GDE No 1186 dated 22.08.22 and informed the fact to the Officer-In-Charge, Matigara PS and as per his kind order and direction myself along with force had been Fulbari Patan to work out the information in hand. After arrival at Fulbari Patan we noticed that the above noted vehicle was coming from Fulbari Patan Ghat. We managed to detained the said vehicle displaying number plate WB/73/E /9356 loaded with illegal River bed materials and also managed to apprehended the driver and co driver as noted above of the said vehicle.
