Sir,
In producing herewith five (05) arrested accused persons namely (i) Shiva Chettri @ Gara (23), S/O- Lt. Suraj Chettri of Mirik Sabani Baazar near Ravinath High School, PS- Mirik, Dist- Darjeeling, (ii) Sachin Gurung (45), S/O- Lt. Gaja Gurung of Belgachi Tea Estate near Football ground, Panighata, P.S- Kurseong Dist Darjeeling A/P Gurung busty, near Gumba, PS Pradhan Nagar, Dist Darjeeling (iii) Bishal Ghosh (21), S/O- Dilip Ghosh of Ratanlal Busty, PS Pradhan Nagar, Dist- Darjeeling, (iv) Dipak Mandal (27), S/O- Lt. Ramdayal Mandal of Satyajit nagar, Tea Auction Road, PS Pradhan Nagar, Dist- Darjeeling and (v) Md. Faruk (21), S/O Abdul Gafur of Nayabusty, Salbari, PS Pradhan Nagar, Dist- Darjeeling (not verified) arrested u/s- 41 Cr.P.C along with following seized articles viz:

- (1) One iron rod measuring 17.5 inch (approx.) including wooden butt from the possession of Shiva Chettri @ Gara which was kept concealed on his back side.
- (2) One iron made 'Sickle' measuring 22.5 inches (approx.) from the possession of Sachin Gurung which was kept on his right hand.
- (3) One iron made 'Sickle' measuring 20.5 inches (approx.) from the possession of Bishal Ghosh which was kept on his right hand.
- (4) One iron Rod measuring 15 inches (approx.) in length found from the possession of Dipak Mandal which was kept on his right hand.
- (5) One iron made Hammer measuring 10 inches (approx.) in length found from the possession of Md. Faruk which was kept on his right hand

I, SI Shibdhan Karmakar of Pradhan Nagar PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted accused persons namely (i) Shiva Chettri @ Gara (23), (ii) Sachin Gurung (45), (iii) Bishal Ghosh (21), (iv) Dipak Mandal (27) and (v) Md. Faruk (21) and others to the effect that today on 25.08.2022 at 22.55 hrs received a sources information that 14/15 youths have assembled at Samar nagar Sarbojonin Football math near Ganga mandir under Pradhan Nagar PS with a view to commit dacoity in Samar Nagar area. The fact was diarized in GD vide Pradhan Nagar PS GDE No-1561 dated 24.08.2022. Subsequently, after sharing the information with my superiors and as per their direction, I along with C/762 Md. Mojibur Rahaman, CV/223 Swapan Chettri, CV/645 Pankaj Das, CV/128 Ajay Kr Sahani, CV/242 Rakesh Mangar left for the place to work out the information. At about 23.45 hrs. we reached at Samar nagar Sarbojonin Football mat near Ganga mandir under PS- Pradhan Nagar and met with my source and being pointed by the source we started walking towards Football math Samarnagar and started cordoning off the suspected persons as shown by the source with a strong reason to believe that they were preparing to commit some cognizable offence and were about to move from the spot seeing police personnel approaching towards them. They tried to flee away in multi direction. After hot chase we managed to apprehend above noted five (05) accused persons along with seized articles as mentioned above. However, the other persons managed to flee away from the spot taking the advantage of darkness. On interrogation the accused persons admitted that they had assembled there to commit dacoity in Samar Nagar area.

I thereafter, seized the above noted weapons under proper seizure list duly acknowledged by the accused persons. The whole seizure was made in between 00.35 hrs. to 01.15 hrs. Thereafter, I arrested the above noted accused persons u/s 41 Cr.P.C under proper memo of arrests duly signed by the accused persons and also supplied the copy of the memo of arrest to them.

I accordingly brought the arrested accused persons along with seized article at Pradhan Nagar Police Station for further investigation. During the course of interrogation, it could be revealed from the arrested accused persons that they were gathered there to commit dacoity in Samar nagar area. It is also revealed from them that Baiju, Pankaj Mahato, Gopal Karmakar, Dev and some others have assembled there with them and planned for committing the dacoity.

Hence, a specific case may kindly be started under proper section of Law against the above noted accused persons viz: (i) Shiva Chettri @ Gara (23), S/O- Lt. Suraj Chettri of MirikSabaniBaazar near Ravinath High School, PS- Mirik, Dist- Darjeeling, (ii) Sachin Gurung (45), S/O- Lt. Gaja Gurung of Belgachi Tea Estate near Football ground, Panighata, P.S- Kurseong Dist Darjeeling A/P Gurung busty, near Gumba, PS Pradhan Nagar, Dist Darjeeling (iii) Bishal Ghosh (21), S/O- Dilip Ghosh of Ratanlal Busty, PS Pradhan Nagar, Dist- Darjeeling, (iv) Dipak Mandal (27), S/O- Lt. Ramdayal Mandal of Satyajit nagar, Tea Auction Road, PS Pradhan Nagar, Dist- Darjeeling and (v) Md. Faruk (21), S/O Abdul Gafur of Nayabusty, Salbari, PS Pradhan Nagar, Dist- Darjeeling (not verified) (vi) Baiju, (vii) Pankaj Mahato, (viii) Gopal Karmakar, (ix) Dev and others and arrange for its investigation.
