In producing herewith one lady accused person namely Sudha Chhetri-42yrs w/o Shri Roshan Chhetri of Jyotinagar, ITI Road, ward no-41 of SMC PS Bhaktinagar Dist Jalpaiguri along with the following seized articles as per proper seizure list:

1. 06 (Six) pet bottles of Himalayan Gold 60 up country spirit each bottle containing 600 ML.

2. 05 (Five) bottles of Imperial Blue whiskey each bottle containing 180 ML

3. 02 (Two) bottles of Imperial Blue whiskey each bottle containing 750 ML which was packed in one big nylon bag.

I beg to report that I, ASI Nitai Mandal of Bhaktinagar PS under Siliguri Police Commissionerate lodged a written complainant against one Sudha Chhetri-42yrs w/o Shri Roshan Chhetri of Jyotinagar, ITI Road, ward no-41 of SMC PS Bhaktinagar Dist Jalpaiguri to the effect that on 27.08.22 at 14.25 hrs received a source information from Jyotinagar, ITI road under Bhaktinagar PS that one lady namely Sudha Chhetri has gathered huge quantity of liquor in her house for selling the same in the open market for her wrongful gain without any documents/license. Diarized the fact in GD vide Bhaktinagar PS GDE No-1658 dated 27.08.22. As per your kind instruction myself along with Lady Police personals and force proceeded to the PO to work out the information. At 14.45 hrs we reached at the spot, sometimes after, being identified by the source our police party held raid and recovered the above noted articles from her possession. During local enquiry it came to learn that she is selling the same in open market since long for her wrongful gain without any valid documents/license. In presence of witnesses I seized the above noted articles from her possession after prepared proper seizure list and arrested her after maintaining all decency and formalities. (The seizure was made in between 14.55hrs to 15.50hrs)

I therefore request you a specific case may kindly be started against the accused person namely Sudha Chhetri-42yrs w/o Shri Roshan Chhetri of Jyotinagar, ITI Road, ward no-41 of SMC PS Bhaktinagar Dist Jalpaiguri under proper section of law and arrange for investigation..
