Sir,

In producing herewith four (04) arrested accused persons namely (I) Bikash Mallick (18yrs) S/O- Prabhu Mallick of Coolypara, near Kall Mandir, Ward No- 01, PS-Pradhannagar, Dist- Darjeeling, (II) Ahamed Ali (20yrs) S/O- Asgar Ali of Adarshanagar Coloney, Near Govt. Saw Mill, Ward No-04, PS- Siliguri, Dist- Darjeeling, (III) Sona Babu Sahani (19yrs) S/O- Mohan Sahani of Durganagar Kumartolly, Ward No.- 04, PS- Siliguri, Dist- Darjeeling and (Iv) Pintu Kumar Pandey (22 year) S/O Ghanashyam Pandey of Vivekananda nagar rail line, Ward No-07, PS- Siliguri, Dist- Darjeeling arrested u/s- 41 Cr.P.C along with following seized articles viz:

- 1. One (01) iron made sword measuring 23 inch (approx) including wooden butt from the possession of Bikash Mallick which was kept concealed on his back side,
- 2. One (01) iron made Hasua measuring 17 inch (approx) from the possession of Ahamed Ali which was kept on his right hand,
- 3. One (01) iron made Sabol measuring 18 inch (approx) from the possession of Sona Babu Sahani which was kept concealed on his back side,
- 4. One (01) iron made 'Knife' measuring 09 inch (approx) from the possession of Pintu Kumar Pandey which was kept concealed on his left pocket.

I SI Subhendu Das of Siliguri PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted accused persons namely i) Bikash Mallick, (ii) Ahamed Ali, (iii) Sona Babu Sahani, (iv) Pintu Kumar Pandey and others namely to the effect that today on 27.08,2022 at 00.45 hrs received a sources information that 12/13 persons have assembled at Adarshanagar Coloney near rail line under Siliguri PS with a view to commit dacoity at Khalpara area. The fact was diarized in GD vide Khalpara TOP GDE No- 611 dated 27.08.2022. Subsequently, after sharing the information with I/C Siliguri PS and O/C Khalpara TOP as per his direction, I along with SI Ashim Kumar Das, ASI- Raju Sarkar, ASI Kala Chand Singha, ASI Uttam Kumar Dhar, C/1183 Nikhil Saha, C/1048 Gopal Roy, C/516 Sunil Roy Dey, CV/980 Ranjan Ojha left for the place to work out the information. At about 01.05 hrs after reaching Adarshanagr, I met my source and being pointed by the source we started walking towards Adarshanagar Coloney near rail line. After reaching Adarshanagar Coloney near rail line started cordoning off the suspected persons as shown by the source with a strong reason to believe that they were preparing to commit some cognizable offence and was about to move from the spot seeing police personnel approaching towards them. They tried to flee away but on hot chase we managed to apprehend above noted four (04) accused persons along with seized articles as mentioned above. However the other persons managed to flee away from the spot taking the advantage of darkness. On interrogation the accused persons admitted that they had assembled there to commit dacoity in a house at Khalpara area.

I thereafter, seized the above noted weapons under proper seizure list duly signed by the witnesses and acknowledged by the accused persons. The whole seizure was made in between 01.35 hrs to 02.15 hrs. Thereafter, I arrested the above noted accused persons u/s 41 Cr.P.C under proper memo of arrests duly signed by the accused persons and also supplied the copy of the memo of arrest to them.

I accordingly brought the arrested accused persons along with seized article at Siliguri Police Station for further investigation. During the course of interrogation it could be revealed from the arrested accused persons that they were gathered there to commit dacoity in a house at Khalpara area. It is also revealed from them that some others have assembled there with them and planned for committing the dacoity.

Hence, a specific case may kindly be started under proper section of Law against the above noted accused persons viz. (I) Bikash Mallick (18yrs) S/O- Prabhu Mallick of Coolypara, near Kali Mandit, Ward No- 01, PS- Pradhannagar, Dist- Darjeeling, (II) Ahamed Ali (20yrs) S/O-Asgar Ali of Adarshanagar Coloney, Near Govt. Saw Mill, Ward No-04, PS-Siliguri, Dist- Darjeeling, (III) Sona Babu Sahani (19yrs) S/O- Mohan Sahani of Durganagar Kumartolly, Ward No. 04, PS- Siliguri, Dist- Darjeeling and (Iv) Pintu Kumar Pandey (22 year) S/O Ghanashyam Pandey of Vivekananda nagar rail line, Ward No-07, PS- Siliguri, Dist- Darjeeling and others and arrange for its investigation.
