In producing herewith one arrested accused person namely Raja Muni (M-67 yrs) s/o Late Mati Muni R/o Bidya Chakra Colony Ward No-44 PS- Bhaktinagar Dist- Jalpaiguri along with seized articles

- 1] 12 (Twelve) Bottles Country Spirit styled as Himalayan Gold 60 UP of 600 ml each, MRP Rs. 120/- Marked as exhibit-A, out of one bottle randomly taken as sample for examination as sample. Marked as exhibit-A-1
- 2] One Nylon printed Bag which used for carrying the seized articles SL. No. 1.

I, SI Uday Shankar Mandal of Panitanki TOP under Siliguri PS, herby lodge a written complaint against the above noted accused person to the effect that on 27.08.2022 at 20.30 hrs received one secret source information that one person was carrying huge quantity of bottled country spirit through Bidhan road opposite of Hotel Dolly Inn Sevok road, Siliguri if come immediate he has been arrested. Accordingly the information was diarized vide Panitanki TOP GDE No. 583 dated 27.08.2022 and informed to O.C. Panitanki TOP and thereafter as per his direction, I along with ASI Biswajit Ghosh, C/702 Latifur Rahaman and C/ 984 Subhasish Das left from Panitanki TOP to work out the information. On arrival at Bidhan road opposite of Hotel Dolly Inn at 20.40 hrs being pointed out by the source, found that one person is proceeding with huge quantity of country spirit containing with a Nylon bag. I intercepted the person Raja Muni (M-67 yrs) s/o Late Mati Muni R/o Bidya Chakra Colony Ward No-44 PS- Bhaktinagar Dist-Jalpaiguri with loaded articles in presence of police witnesses. During interrogation the accused failed to produce any documents/license in support of the same and stated that he sale the same to the local public at Bidya Chakra Colony adjacent area illegally with a view to earn huge money for his lively hood. Accordingly, I seized (1) 12 (Twelve) Bottles Country Spirit styled as Himalayan Gold 60 UP of 600 ml each, MRP Rs. 120/- and 2) One Nylon printed Bag which used for carrying the seized articles SL_No. 1 under proper seizure list and labeled the same in presence of witnesses and duly signed by them and also by the accused person. The seizure was made between 20.45 hrs. to 21.10 hrs. I then arrested the accused person u/s 41 Cr.P.C. after explaining charge against him. The local public was also annoyed with him because of his this kind of illegal activities. As such there was no scope to serve Notice \mathfrak{u}/s 41A of Cr.P.C,

Hence, under the above noted circumstances I am submitting this written complaint against the above accused person namely Raja Muni (M-67 yrs) s/o Late Mati Muni R/o Bidya Chakra Colony Ward No-44 PS- Bhaktinagar Dist- Jalpaiguri for starting a specific case under proper section of Law and to arrange for its investigation.
