- ii) One Black Colour motorcycle Hero Honda ,CBZ having Reg no- WB 74 P 2377
- iii) One Sky Blue Colour "LAVA" keypad mobile phone,
- Cash rupees Three thousand Two hundred and Fifty only (Rs 3250/-) Indian Currency note in the following denomination Rs 500 x 2= RS 1000/-, 200 x 6= Rs 1200/-, Rs 100 x 10= Rs 1000/- and Rs 50/- Total amounting Rs 3250/- under proper seizure list, labeling and memo of arrest.

I. ASI Siben Sarkar of Siliguri PS, Siliguri Police Commissionerate do hereby lodge this written complaint against the above noted accused person namely Santu Das (30yrs) S/o- Mantu Das of Santinagar, Baubazar near Santinagar NavaYuva Sangha Club, PS- Bhaktinagar, Dist- Jalpaiguri to the effect that on 27.08.22 at 19.45 hrs while performing Plain Cloth patrolling duty received a secret source information that the above noted person was selling Id Liquor illegally at Dabgram area near Polytechnic College on a contact over a telephone to his designed customer on his motorcycle having Reg no- WB 74 P 2377 under Siliguri PS in order to clandestinely dispose the same. Accordingly I informed the fact to IC Siliguri PS and as per his direction I along with other officer and forces left for Dabgram area under Siliguri PS vide GDE no- 1667 dated 27/08/22. On reaching at 20:15 hrs there and as identified by the source cordoned the above noted area where he was supplying the illegal alcohol. On seeing the police party the above noted person tried to escape by speeding his motorcycle from the spot but we manage to apprehend the above noted person and on interrogation he disclosed his identity as noted above. On being asked he stated that he used to sale the 60 up country Spirit to local people and Student at Dabgram and Polytechnic College area without any valid documents as he violated the norms of Bengal Excise Act for selling the said seized Liquor without any valid License. On search (i) Thirty Six (36) Sealed Bottles Himalayan Gold premium 60 Up Country Spirit each containing 600 Ml each labeled as Himalayan Endeavour PVT Ltd. Siliguri, West Bengal @ Rs 120 each(Amounting of Rs. 120/-x 36 = Rs 4320/-), in which one sealed bottle has taken from mother packet as sample (ii) One Black Colour motorcycle Hero Honda, CBZ having Reg no- WB 74 P 2377, (iii) One Sky Blue Colour "LAVA" keypad mobile phone, and (iv) Cash rupees Three thousand Two hundred and Fifty only (Rs 3250/-) Indian Currency note

On being interrogation he could not produce any valid documents in respect of said liquor. He also stated that he is doing this Liquor business since long for his wrongful gain. Accordingly 1 seized the same in presence of witness duly signed by them. The seizure and label was made in between 20:25hrs to 21:15 hrs. As such 1 arrested him U/S-41 Cr.P.C after observing all legal formalities.

Therefore I pray before your honor that a specific case may kindly be started against the arrested accused person namely Santu Das (30yrs) S/o- Mantu Das of Santinagar, Baubazar near Santinagar NavaYuva Sangha Club, PS- Bhaktinagar, Dist- Jalpaiguri along with seized articles under proper section of law and arrange for its investigation.
