I, PSI-Pradeep Diyali presently attached with NJP PS under your kind control beg to state that today i.e. on 27.08.2022 at 18.50 hrs I received a secret source information that one person namely Bijoy Modak (42) S/O Suresh Ch. Modak of Pabna Colony, P.S- Kaliaganj, Dist.- Uttar Dinajpur A/P Nepali Busty, Ward No. 34, P.S- NJP, Dist.- Jalpaiguri is selling ID liquor illegally at his hotel stylled as Perona Hotel at NJP Hotel line area under PS- NJP, Dist.-Jalpaiguri. Accordingly, I diarized the fact in the General diary vide NJP PS GDE No. 1355 dated 27.08.2022 and informed the fact to you. As per your kind direction and instruction myself along with HG/794 Ranjit Roy, VP/ 08 Laxman Roy, all of NJP PS, SPC lest for NJP Hotel Line area under PS-NJP, Dist.- Jalpaiguri to work out the information in hand. At about 19.15 hrs we arrived NJP Hotel Line area, PS- NJP, Dist.- Jalpaiguri and being identified by the source I found the said accused person selling Illegal liquior to his regular customer at his hotel stylled as Perona Hotel at NJP Hotel Line area and as per the indication of source managed to apprehended him. During interrogation he disclosed his identity as noted above and also disclosed that he is selling ID liquor at his hotel stylled as Perona Hotel at NJP Hotel Line area under NJP P.S since long for his illegal gain. On search the above noted I/D liquor recovered from his possession. On demand he failed to produce any documents/licence in respect of store/sale the I/D liquor recovered from the bag carrying by him Accordingly, I seized the above noted I/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search & seizure was made in between 19.25 hrs to 19.55 hrs.
