I, LSI Angela Regmi of Bagdogra PS, Siliguri Police Commissionerate, do hereby lodge written complaint, on producing one arrested accused person namely Anupa Munda (37) D/o Lt. Laju Munda of Kamalpur Tea Estate PS Bagdogra Dist. Darjeeling under arrest along with following seized articles;

- 1. Eighteen (18) sealed Bottles of Emboss Fine Whiskey, each bottle 750 ml, Marked as exhibit-A in which 01 bottle taken as sample for examination exhibit-A1.
- 2. Twelve (12) sealed Bottles of Kingfisher Strong Premium beer, each bottle 650 ml each Marked as exhibit –B in which 01 bottle taken as sample for examination exhibit-B1

I am submitting a written complaint against the above noted accused person to the effect that today on 03.09.22 at 12-57 hrs myself alongwith SI Binup Mahato, , CV- 386 Kishor Hawlder CV- 389 Janak Singh, VP-01 Ansalam Kujur LCV-211 Jayanti Barman were performing Special evening Mobile duty vide Bagdogra PS GDE No. 109 dt. 03.09.22. At 15-15 hrs received secret source of information that one female person was selling Id Liquor illegally from her house at Kamalpur Tea Estate to its customers without any valid license. Accordingly I informed the matter to O.C. Bagdogra PS and as per his instruction myself alongwith other officer and force left for Kamalpur Tea Estate to verify the veracity of information. On arrival at the spot at 15-25 hrs it was found that one lady mentioned above was selling liquor illegally from her house at Kamalpur Tea Estate to designated customers to earn huge money for her livelihood. On seen the police party the customers as well as seller tried to flee away, but the seller was apprehended by police. On being asked she disclosed her name and address mentioned above. Thereafter in presence of witnesses namely (1) Renuka Oraon (33) s/o Pental Oraon of Ho-Chi-Min Nagar PS Bagdogra Dist. Darjeeling and (2) Manoj Kr. Roy (38) s/o Mouja lal Roy of Kamalpur Tea Estate, PS Bagdogra Dist. Darjeeling I recovered 1. Eighteen (18) sealed Bottles of Emboss Fine Whiskey, each bottle 750 ml 2. Twelve (12) sealed Bottles of Kingfisher Strong Premium beer, each bottle 650 ml each from the possession of the apprehended lady from her house and seized the same as per proper seizure List and labelled duly signed by her and also witnesses. On being asked she failed to produce any document or license for selling the liquor and confessed her guilt. As such I arrested the above noted accused person u/s 41 Cr.P.C. as It's a violation under Bengal Excise Act while strictly maintaining her modesty. This seizure & arrest was made in between 15-35 hrs and 16-15 hrs (seizure Total approx 21.3 Ltrs).

Therefore, I request you to start a specific case under proper section of law against the arrested person namely Anupa Munda (37) D/o Lt. Laju Munda of Kamalpur Tea Estate PS Bagdogra Dist. Darjeeling and arrange for its investigation.
