

In producing herewith one accused person named Priyanka Jha(29) W/O- Arbind Pfilangara lunction, PS- Producing Company of the Cooliepara Junction, PS- Pradhannagar Dist- Darjeeling, along with the following seized articles:

1. 25(twenty five bottles of Russell's premium whisky each bottle containing 750 ml. blended & bolted by Mayell & Fraser Pvt. Ltd. Bageykhola, Majhitar, Rangpo, Sikkim, India.

l, SI Sibdhan Karmakar of Pradhannagar P.S under Siliguri Police Commissionerate do here by lodged a written complaint against Priyanka Jha(29) W/O- Arbind Jha of Cooliepara Junction ,PS- Pradhannagar Dist- Darjeeling to the effect that today on 06/09/2022 at 14:20 hrs. Received a specific input from the source that the above noted lady has kept huge numbers of illicit liquor in her house at Cooliepara, Siliguri Junction in order to sale the same to her design customers without any valid license for wrongful gain . Accordingly the fact is diarized vide Pradhannagar ,P.S. G.D.E. NO-348 date 06/09/2022, and informed the fact to you. As per your direction I along with ASI Ashit Singha , L/C-720 Mithu Kabiraj, CV 223 Swapan Chettri and CV-128 Ajoy Sahani left for Cooliepara, Siliguri Junction under Pradhannagar PS to verify the veracity of the information. On reaching there and as identified by source cordoned the house where she kept illegal alcohol. On arriving there found the above noted person who disclosed her name & identity as noted above who kept the same at her house in conceal position. On searching found 25(twenty five bottles of Russell's premium whisky each bottle containing 750 ml. blended & bolted by Mayell & Fraser Pvt. Ltd. Bageykhola, Majhitar, Rangpo, Sikkim, India .On being interrogation she could not produce any valid documents/license or authority in respect of the said illicit liquor.she also stated that she is doing this liquor business since last few months for her wrongful gain. Accordingly I seized the same in presence of witness as per proper seizer list duly signed by the witnesses. The seizure was made in between 15:40 hrs to 16:15 hrs. All the seized liquor are Sikkim made liquor. Following which West Bengal Government revenue has been lost. Apart from this local people are very much annoyed for selling the said illicit in said area. On being asked she stated that she kept the same with a view to sale and supply at Cooliepara area without any valid documents. As she has violated the rules and norms of Bengal Excise Act as such I arrested her with help of Lady constable Mithu kabiraj after observing all sorts' arrest rules for selling the said illicit without valid license.

Therefore I pray before your honour that a specific case may kindly be started against accd. Priyanka Jha(29) W/O- Arbind Jha of Cooliepara Junction, PS- Pradhannagar Dist- Darjeeling as per proper section of law.
