This refers to Milanpally out post GDE No 69 date 03.09.22. On arrival at Dudhia Baluchar near ICDS centre at 18.45 hrs and I called two local witnesses to witness the raid and on being identified by the engaged source we held raid in the house of Nipu Roy and could recover the above noted of liquor. During raid the above noted accused person was arrested from whose exclusive possession the above noted liquors were found. On demand he could not produce any license/documents in support of his possession. On interrogation he admitted that he has been running the business clandestinely since long.
