Sir,

With due respect and in producing herewith one accused person namely Amit Mangar (23), S/O Bal Bahadur Mangar of Gassok, PO- Nomobu, PS - Kalimpong, Dist- Kalimpong under arrest along with One vehicle JCB bearing Reg. No. WB 73 F 1786 under proper seizure, I do hereby lodged a written complaint to the effect that on 09.09.2022 at 07:55 hrs onwards I received information from my reliable source that some illegal digging going at Fulbari Patan Ghat by JCB. On receiving the information, I informed to O/C Matigara PS and as per kind order of O/C Matigara I along with other forces of Matigara PS rush to the spot to work out the information. On arrival at Fulbari Patan Ghat found one vehicle JCB bearing Reg. No. WB 73 F 1786 was engaged in digging of river bed materials from Fulbari Patan Ghat. Accordingly, I apprehend the driver of the JCB who disclosed his identity as Amit Mangar (23), S/O Bal Bahadur of Gassok, PO- Nomobu, PS - Kalimpong, Dist- Kalimpong and admitted that he was engaged in digging of river bed materials under instruction of the owner of the vehicle for their wrongful gain. As such I seized the above noted vehicle JCB bearing Reg. No. WB 73 F 1786 under proper seizure list in presence of available witnesses and arrested the driver under proper memo of arrest and brought to the above noted vehicle at P.S.

Therefore I pray before you a specific case may kindly be started against the driver namely Amit Mangar (23), S/O Bal Bahadur Mangar of Gassok, PO- Nomobu, PS - Kalimpong, Dist- Kalimpong and owner of the seized vehicle JCB bearing Reg. No. WB 73 F 1786 under proper section of law and arrange for its investigation.
