That on the 14<sup>th</sup> of August, 2022, I, Shri Subhasish Mangraty, S/o Shri Umesh Mangraty, resident of Don Bosco Colony, Jyotinagar, Pragati Path, Ward No-41, Dist-Jalpaiguri, P.S. - Bhaktinagar, Siliguri - 734001 aged about 24 years had gone to visit Gazaldoba along with my three friends (namely Shri Avishek Shome, Shri Rakesh Roy and Shri Rakesh Prasad Sahu) for the purpose of photography.

That on the said date, at around 01:00 p.m., while on the way to the said destination, I was riding my two-wheeler motor-vehicle [Royal Enfield (Continental GT-650)] bearing registration number- WB-74-BH-1530 along with one of my friend namely Shri Rakesh Prasad Sahu, as the pillion rider.

That suddenly, a recklessly driven speeding Four-wheeler vehicle [**Pick-up goods carrier vehicle**] coming from the opposite side, dangerously drove into the wrong lane and directly hit me and the pillion rider (Shri Rakesh Prasad Sahu) of my two-wheeler motor-vehicle that I was riding.

That right after the incident took place, the driver of the said four-wheeler vehicle fled away with the said four-wheeler vehicle from the spot; my other two friends (namely Shri Avishek Shome and Shri Rakesh Roy) who were right behind me riding in another two-wheeler vehicle also witnessed the entire incident.

That due to the said hit/crash by the said four-wheeler vehicle, I was grievously and seriously injured and my friend (pillion rider) also received major injuries. Further, I was unable to move my body due to the injuries, so, I was helped by my said friends and some local people and was first taken to Maharaja Agrasen Hospital but due to the seriousness of my inflicted injuries I had to be immediately transferred to the emergency unit of Neotia-Getwel Healthcare (Hospital) at Matigara.

That due to the hit, I received grievous physical injuries to my left leg which was broken in two parts at the tibia and at three places at the fibula, a dislocated left hand and injuries to his lower abdomen and face. [medical report(s) have been attached herein]

That the next day, it came to my knowledge that the driver of the said four-wheeler vehicle who fled away with the said four-wheeler vehicle from the spot, was stopped and intervened by local people around a distance of 1 km away from the spot/place of said incident.

That during the event of the said incident, I lost my back-pack containing my wallet which contained my Pan Card, Aadhaar-Card, Driving Licence and an ATM Card of Bandhan Bank along with cash of Rs.2500 (approx.) and my registration and insurance documents of my said two-wheeler motor-vehicle and two lens of his Nikon Camera worth around Rs. 40,000/- (Rupees Forty Thousand) only.

That I had to be kept at Neotia-Getwel Healthcare (Hospital) from 14/08/2022 to 23/08/2022 and was discharged after being operated thrice and am still visiting the said hospital for further follow-up check-up(s)/treatment(s). As because of the injuries sustained due to the incident, and the mental pain and agony in result of such incident, I am not able to do daily chores or activities of life conveniently, therefore, the delay in lodging this said complaint.

That, in view of the above facts, I pray before your office to take efficient action(s) against the owner and the driver of the above mentioned Four-wheeler vehicle for causing grievous hurt to me by the act of endangering my life, and also for dangerously driving with rashness and negligence which coursed the way to the incident effecting my personal safety and endangered my life. On the same note, it brought physical pain and mental pain and agony to me and the loss of property, financial loss and also the loss of the above mentioned article(s) and document(s).
