GAIL(India)Limited, A Maharatna Company, under the aegis of Ministry of Petroleum & Natural Gas, Govt. of India, has been authorized to lay approx. 712 Km length of natural gas pipeline in the state of Bihar, West Bengal and Assam. The proposed pipeline passes through Uttar Dinajpur, Darjeeling, Jalpaiguri, Cooch Behar and Alipurduar Districts of West Bengal State.

In Jalpaiguri District, the pipeline route has been finalised and as per P&MP Act 1962, 6(1) Gazette Notification has already been published of 47 Mouzas / Villages of length 62 Km of RoU by MoP&NG (Ministry of Petroleum & Natural Gas).

Further, the locations of Sectionalizing Valve (SV) Station / Intermediate Pigging (IP) Station, which is essential for monitoring and controlling of Natural Gas flow are already finalized and accordingly GAIL has purchased SV-12 land measuring around 67 decimal area at Village: Binaguri (16)-03, Block: Rajganj, District: Jalpaiguri, West Bengal through direct negotiation from the concerned land owners (**Copy of Registration and Mutation in the name of GAIL is attached**). The detail of SV-12 land already purchased by GAIL is given below: -

In spite of several discussions done by our agency with him for convincing and resolving the matter by showing the mutation copy in the name of GAIL, he is not allowing to carry out the work and creating hindrance in ongoing Govt. job. It may also be noted that our executing agency already mobilised all heavy equipments and manpower for the pipeline activities and are in idle condition incurring huge financial loss which in turn will affect the overall project cost to GAIL.

As this project is of national importance and for the development of the state, it is earnestly requested to your good office to extend the necessary support to GAIL team for successfully carrying out the construction work of SV-12 at Mouza- Binaguri (Sheet-16), Block- Rajganj, District: Jalpaiguri without any hindrance and in a peaceful manner. **This letter may be treated as FIR against Mr. Unis Ali .**
