Sir,

Most humbly I the undersigned apprising you that I am attorney of Parijat Chakraborty and Nihar Ranjan Chakraborty both are residents of "Parijat P.O. Lake Town, P.S. NJP Dist. Jalpaiguri, Pin- 734 007 and they are the owner of the schedule land by virtue of three Deeds of Sale being No. 1288 dated 15<sup>th</sup> October, 2020, Deed No. 1-2766 dated 8<sup>th</sup> July, 2020 & vide Deed No. 2765 dated 8<sup>th</sup> July, 2020 and have acquired the land. That the schedule land is recorded in their name vide L.R. ROR being No. 385 & 386 and they are in possession by raising boundary walls and planted different types of fruits trees and constructed dwelling house in a portion thereon and also an iron gate. That Nabendu Dey who is the director of the Sunshine Agro Infra Limited & Nitesh Periwal, who is well known land grabber in the locality along with their men and securities came to our schedule land by one blue and one black vehicles and tried to encroach our schedule land by breaking the iron gate with an iron rod and stones in their hands. All the incidents has been captured in our C.C.T.V. Camera where it can be clearly seen. That on this schedule land there is an order of Injunction by the Ld. Civil Judge Junior Division (1<sup>st</sup>), Jalpaiguri vide Title Suit No. 343 of 2022 order dated 28-07-2022 and also WRIT matter being W.P.A. No. 2533 of 2022 is pending before Calcutta High Court, Circuit Bench at Jalpaiguri. That insptie of having the Injunction order passed by the Ld. Court on the schedule land they are violating the solemn order of the Ld. Court. That in the shown information we are hereby request you to kindly protect our possession and implement the order of the civil court.
