Sir,

I Smt. Sarathi Roy, W/O. Sahadeb Roy, aged about 27 yrs, resident of Bholanath Para, Ektiasal, Bhaktinagar, Dist. Jalpaiguri do hereby inform you that I am a pregnant housewife of 7 months. But unfortunately, I have been frequently tortured and assaulted by my 'Boudi' namely Anuradha Roy, W/O. Himangshu Roy (wife of my husband's elder brother) on different pleas and silly matters since I got pregnant. Yesterday in the evening, while I was doing my daily household work, the said Anuradha Roy attacked on me barbarously. She suddenly pulled my hair forcibly and kicked on my lower abdomen heavily. I fell down on the ground and got serious injury on my back and abdomen. I cried in unbearable pain that caused me to be admitted in Siliguri hospital. It is to be mentioned that the said Anuradha is assaulting and torturing on me since long for grabbing our share of the family property. She is quarrelling and desperate in nature and often threatens me that she will destroy the baby inside me.

Today, after I was discharged from the hospital and returned to home, she again threatened me that she will not spare me and I have to soon face a dire consequence. My husband is a driver by occupation and so he remains absent in the house most of the time. Doctors advised me to take rest and avoid all sorts of mental stress. But my life including the baby inside me is not safe due to frequent and sudden assault by their desperate nature of Anuradha Roy. I am suffering from acute physical and mental pain for she is endangering my life in such pregnant state. There are many neighbours/local inhabitants who are well known about this matter.

Therefore, I cordially request you to investigate the matter as soon as possible and take proper action against the said Anuradha Roy so that my life including the baby inside me can be saved. I hope you will be kind enough considering the situation and thus save me from any impending danger.
