

- One multi-colour nylon bag containing sl. No. I to Sl. No. IV which were kept inside a black colour (V) plastic bag.
- One black colour Honda scooty without number plate. (VI) [Sl. No. I to Sl. No. V found inside Sl. No. VI]

l, PSI Newton Biswas of New Jalpaiguri Police station, Siliguri Police Commissionerate do here by lodge this written complaint against above noted three (03) arrested accused persons to the effect that today 08.09.2022 at about 13.55 hrs I received a specific source input that three (03) persons were coming at Porajhar in front of Utsodhaara under NJP P.S with a scooty without number plate with a huge quantity of Brwon Suger for delivering the same to their designed customers. The matter was diarized vide NJP PS PS GDE No. 365 Dt. 08.09.2022 and I informed the matter to SI Partha Sarathi Das, Officer-In-Charge, New Jalpaiguri Police Station in writing a letter to him and expressed the entire information. As per his kind direction myself along with other officers and force named ASI Sajal Das, VP/08 Laxman Roy, HG/794 Ranjit Roy all of NJP PS, Siliguri Police Commissionerate along with Van officer SI Shib Shankar Das and forces C/1035 Santosh Rabi Das and C/861 Swapan Dhar, being headed by me left for Porajhar, in front of Utsodhaara by govt. vehicle with investigation kit to verify the veracity of the information in hand vide NJP PS GDE No 367 dated 08.09.2022 and M.C.C. No. 1334/2022 dated 08.09.2022. In the mean time I also informed the Videographer namely Tapan Mandal s/o Testo Mandal of Bhola More, PS- NJP, Dist.- Jalpaiguri to be present at Porajhar More to prepare the Video of whole process of search and seizure if any. I also informed Van officer SI Shub Shankar Das Under this circumstances any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidences of facility for the escape of the offender. At about 14.35 hrs we arrived at Porajhar in front of Utsodhaara and on the way to the spot, I called two independent witnesses namely (i) Sahil Khan (24) S/O Lt. Md. Jabat of Gurung Busty near Model High School, P.S- Pradhannagar, Dist.- Darjeeling (ii) Dilip Sha (35) S/O Ram Lagan Sha of South Baghajatin Colony, P.S- Pradhannagar, Dist.- Darjeeling and disclosed our identity and informed them about the information in hand and requested them to accompany us and remain present in the whole process during search and seizure if necessary with a written letter and necessary permission of their presence and act as witnesses under relevant provision of law. After arrival at the spot and as identified by the source we found that three persons with a scooty standing at Porajhar in front of Utsodhaara under PS- NJP, Dist.-Jalpaiguri which was matched with our information. Accordingly, we intercepted the above three (03) who disclosed their identity as noted above.

After disclosing our identity, we detained the above noted accused persons with a strong reason to believe that they illegally possessing brown Sugar in their conscious and joint possession which they are carrying for selling the same to their designed customers for their wrongful gain. On being asked they confessed that they possessed brown Sugar inside the scooty under their conscious and joint possession. I then gave them option in writing whether they wanted to be searched in presence of Executive Magistrate or by any Police Gazetted Officer Then they agreed to be searched by any one of them. Further, I served them a notice in accordance with provisions of law in this regards. I also offered the independent witnesses and the apprehended persons to search our Police Party as per provision of law but they denied to search police party. Accordingly, I informed the matter to the Officer-In-Charge, NJP PS and as per his kind order I informed the fact to Shri Ashish P. Subba , WBPS Assistant Commissioner of Police, Traffic West, Siliguri Police Commissionerate detailed for acting as Specia Executive Magistrate, of SPC for the day regarding the interception of the accused persons suspected to be possessed of Brown Sugar and requested him to come to the spot and to supervise the search and seizure being a gazette officer. Accordingly at 16.15 hrs Shri Ashish P. Subba , WBPS, Assistant Commissioner of Police, Traffic West, Siliguri Police Commissionerate arrived at the spot and accordingly, I disclosed his identity to the detained persons as Special Executive Magistrate of Siliguri Police Commissionerate.

Subba, WBPS, Assistant Commissioner of Police, Traffic West, Siligui mmissionerate detailed as Special Executive Magistrate and two independent public witnesses searched ty and recovered after following all formalities keeping their decency and recovered total 04 (four ent plastic packets containing said to be Brwon sugar kept inside a black colour plastic bag and the sam inside a multi colour nylon bag and found inside the scooty.

Thereafter, I weighted 03 (three) recovered packets containing said to be Brown Suger in presence of Shi P. Subba, WBPS, Assistant Commissioner of Police, Traffic West, Siliguri Police Commissionerate detaile ng as Special Executive Magistrate, of SPC for the day and the independent witnesses with the weighin ient and found total 98 [Ninety- eight grams] of suspect to be Brown Sugar Marked as Exhibit-"A", total 10 ndred grams) of said to be Brown Sugar and Marked as 'Exhibit B', total 100 (one hundred grams) of sai rown Sugar and Marked as 'Exhibit C' and total 100 (one hundred grams) of said to be Brown Sugar an as 'Exhibit D'. Further, on demand in presence of Shri Ashish P. Subba, WBPS, Assistant Commissione e, Traffic West, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate, of SP day as well as independent witnesses the above noted detained persons failed to produce any vali ents in support of possessing of Brwon Sugar. Thus when their involvement in carrying and possessin sugar were established, then I seized the above noted articles from the conscious and joint possession ( ove noted accused persons at the spot at Porajhar in front of Utsodhaara under PS NJP, Dist.- Jalpaigu proper seizure list in presence of Shri Ashish P. Subba , WBPS, Assistant Commissioner of Police, Traffi Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate, of SPC for the day as we ependent witnesses as noted above and acknowledged by the accused persons. Subsequently, I labeled th articles in presence of Shri Ashish P. Subba, WBPS, Assistant Commissioner of Police, Traffic West, Siligui Commissionerate and independent witnesses and accused persons as noted above. The whole process ( e and labeled was made in between 16.25 hrs. to 17.35 hrs on 08.09.2022. On further asked they confesse esence of Shri Ashish P. Subba , WBPS, Assistant Commissioner of Police, Traffic West, Siliguri Polic lissionerate acting as Special Executive Magistrate and other witnesses that they procured the brown sugs estinely from Malda for the purpose of supply the same to their designed customers at Siliguri area as pe requirement for their personal gain by illegal means. On interrogation they also disclosed that they have bee ig in such business of selling the brown sugar illegally for last few months.

From the above noted facts and seizure of incriminating articles it is quite evident that the accuse ns namely 1. Sonu Sah (22) S/O Lalbabu Sah of Gurung Busty, Durga Nagar Colony, P.S- Pradhannaga Darjeeling (Not verified), 2. Md. Jabbar (36) S/O Md. Ful of South Baghajatin Colony, P.S- Darjeeling (Not verified) and 3. Saddam Hussain (24) S/O Alamgir Hussain of South Baghajatin Colony, P.S- Darjeeling (Not verified) are involved in procuring and selling of Brown Suger illegally an nanagar, Dist.
