Sir,

With due respect, I am producing herewith the arrested accused persons namely (i) Zinnat Ali (52) s/o Md. Hafizuddin of Akarigach, Vestpara, PS- NJP, Dist.- Jalpaiguri (ii) Manirul Haque (23) s/o Abdul Karim of Haricharanvita, PS-NJP, Dist.- Jalpaiguri (iii) Azizar Rahaman (26) s/o Md. Azibuddin of Jatiyakali, PS- NJP, Dist.- Jalpaiguri and the following articles under seizure :-

- 1 One iron made sharp cutting weapons called as Hasua and one Blunt Iron Rod used for breaking the Locks and One Hammer from the possession of Manirul Haque (23) s/o Abdul Karim of Haricharanvita, PS-NJP, Dist.- Jalpaiguri
- 2 One iron made sharp cutting weapons called as Bhojali and One Charger Torch Light and Iron Rod length 30 Inch from the possession of accused
- 3 One sharp cutting knife and one torch light and One Screw Driver from the possession of accused Zinnat Ali (52) s/o Md. Hafizuddin of Akarigach, Vestpara, PS- NJP, Dist.- Jalpaiguri

I, ASI Sajal Das of NJP PS, Siliguri Police Commissionerate beg to state that on 11.09.2022 at 01.35 hrs received a secret source information that that a gang of miscreants come at near Goatmabari, near Mahananda barriage, PS- NJP, Dist.- Jalpaiguri with deadly weapons and assembled there and making preparation for committing dacoity at Goatmabari and Fulbari area. Accordingly, I diarised the fact in General Diary vide NJP PS GDE No 508 dated 11.09.2022 and informed the fact to you as well as Asstt Commissioner of Police, East -II, SPC about the information. I also informed the fact to night RT Van SI Pintu Ghosh and requested them to come to Goatmabari near Mahananda Barriage to accompany with us. At 0155 hrs. we arrived at Goatmabari under PS- NJP, Dist.- Jalpaiguri and ambush there. After a few time RT Van officer namely SI Pintu Ghosh along with force came to near Goatmabari and accompany with us. At about 0205 hrs as indicated by the source we noticed that 08/09 persons assembled in a dark place at Goatmabari near Mahananda Barriage, PS- NJP, Dist.- Jalpaiguri and they were whispering in a very low voice. Accordingly, we cordoned the place properly and approach towards them very slowly and carefully but seeing the police party they started to flee away but we the police party managed to apprehended 03 (three) of them with deadly weapons in their possession. On interrogation the apprehended accused persons disclosed their name and identity as noted above.

During further interrogation they give different statement in different time and failed to give any satisfactory reply for their presence in middle of the night with deadly weapons. Finally they disclosed that they assembled there for committing dacoity at Goatmabari and Fulbari area. Accordingly, I seized the above noted weapon of offence from their possession under proper seizure list and arrested the above noted 03 (three) accused persons under proper memo of arrest and observing all the formalities of arrest and brought them to NJP PS. The search seizure and arrest made in between 0225 hrs to 0255 hrs hrs on 11.09.2022.

Under the above noted fact and circumstance, I therefore pray to you that a specific case under proper section of law may kindly be started against the arrested accused persons namely (i) Zinnat Ali (52) s/o Md. Hafizuddin of Akarigach, Vestpara, PS- NJP, Dist.- Jalpaiguri (ii) Manirul Haque (23) s/o Abdul Karim of Haricharanvita, PS-NJP, Dist.- Jalpaiguri (iii) Azizar Rahaman (26) s/o Md. Azibuddin of Jatiyakali, PS- NJP, Dist.- Jalpaiguri and others and arrange for its investigation.
