I, Phuldevi @ Fuldevi Sahani wife of Angar Sahani resident of Sagina Mahato Road, Subhaspally, P.S Siliguri District Darjeeling would like to inform you that I had purchase a land along with a house adajadent of my house at Sagina Mahato Road from Bhola Sahani son of late Luro Shanai presently residing at Gurung Basti Pradhananagar District Darjeeling . That the said Bhola Sahani had taken a loan from Graib Sahani son of resident of Sagina Mahato Road, Subhaspally, P.S Siliguri District Darjeeling who also reside within the same locality, however as he couldnot repay the loan the said Garib sahani had threatened me that he will forcefully take the possession of the land of Bhola Sahani which Bhola Sahani has sold to me. That on 11/9/2022 at 4.30 pm the said Garib Sahani, Lalit Sahani son of Garib Sahani, Bajnath Sahani son of Garib Sahani, Sujit Sahani son of Garib Sahani, Ahelia Sahani wife of Garib Sahani, Mamta Sahani wife of Bajnath Sahani ,Poonam Sahani wife of Rithesh Sahani, Rithesh Sahani, Manju Sahani and others had broken the lock of the house which I have purchased from Bhola Sahani and they forcefully entered the house and were taking my belonging like utensils, TV, etc and when my daughter in law Ashmita Sahani tried to resist them, , Garib Sahani his sons namely, Lalit Sahani, Bajnath Sahani, Sujit Sahani and Rithesh Sahani started using vulgar language against my daughter in law and also pulled the hair of my daughter in law and started assaulting her and when she tried to get out of their clutches they pulled her saree and disrobed her.
