Darjeeling and 20/25 unidentified male and female persons of Biswas Colony, PS- Matigara, Dist.- Darjeeling to the effect that today i.e. on 14.09.22 at 12:15 hrs I received a secret information that one Md Ekram @ Babu of Biswas Colony, PO+PS- Matigara, Dist- Darjeeling is moving at Biswas Colony under PS- Matigara, Dist.-Darjeeling with one automatic fire arms loaded with live ammunition, probably for committing some heinous crime. Accordingly, I diarized the information in General diary vide Matigara PS GDE No 816 dated 14.09.2022 and informed the fact to the officer-in-Charge, Matigara PS.

At about 12.25 hrs, we reached Biswas Colony under PS- Matigara, Dist.- Darjeeling and after sometime RT Van officer ASI Abhijit Chanda

As identified by the source, we were able to apprehend the said Md Ekram @ Babu at Biswas also arrived there and accompanied us. Colony near Rail gate. On being asked he disclosed his identity as noted above. In presence of local witness namely Jagadish Yadav S/O Late Mantu Yadav of Alam Busty, Promod Nagar, PS- Matigara, Dist. Darjeeling, I searched the detained person and recovered 01 improvised automatic small fire-arms (pistol), barrel length measuring 15 cms and butt length measuring approx 09 cms, having the mechanism of trigger, trigger guard, firing pin & firing hammer and Magazine, loaded with 01 (one) round of ammunition (KF7.65) from the possession of the above noted accused which he kept conceal in his waist

below his cloths. The handgrip of the pistol has "Sunni INDUS" words on it. In the meantime a mob consisting of 20/25 unidentified men and women of the said locality, being armed with lathis, iron rods etc, under the leadership of Bunu Begam (Wife of detained Ekram) W/O Md Ekram @ Babu of Biswas Colony came to the spot and forcibly started to prevent the police party to take custody of the apprehended person from the custody of the police but they failed to do so. The wife of the

apprehended person, bit me on my right hand as a result of which I sustained grievous injury.

Then the said mob became very ferocious and started to assault police personnel and pelted stones at the police vehicles. The mob camaged the police vehicle bearing Registration No WB/77/4723 and broke the window pane of the said vehicle. In this assault myself along with ASI Dhirendra Nath Mandal, LC/1286 Anisha Chhetri and C/974 Mintu Sen sustained injuries. Seeing the situation getting graver, I informed the fact to the O/C, Matigara PS over telephone and requested to send more police personnel to tackle the situation. After some time more police personnel came to the spot at Biswas Colony and seeing the arrival of police personnel the mob fled away from the spot. Myself along with other injured police The detained accused namely Md Ekram @ Babu (32 yrs) S/O Md Dilwar Hussain of Biswas

Colony, PO+PS- Matigara, Dist- Darjeeling failed to produce any document in support of the said

imprevised fire arm and live ammunition which was found in his possession. Accordingly I seized that improvised fire arm and 01 (one) round live ammunition under proper seizure list duly acknowledged by the accused person and marked as Exhibit "A" & Exhibit "B". The search, seizure and label was made in between 13:15 hrs and 13:50 hrs on 14.09.22 and I arrested him by preparing memo of arrest informing him the ground of arrest.
