Jalpaiguri, would like to inform you that, my elder son namely Prasanta Goldar aged about 26 years entered into the marriage with one Shibani Goldar (Poddar), D/o. Late Satyaban Poddar in the year of 2018 as per their own wish and without our consent. It is very shameful to inform you that the wife of my son Smt. Shibani Poddar is the niece of my wife (wife's cousin brother's daughter).

I would like to further inform you that, due to the said marriage, I alongwith my family members did not accept the said relation and they both have started to reside in a rented house here and there and since long there was no contact with my son and his wife.

I would like to further inform you that, in the year of 2020 the wife of my son gave birth of a male child and after his birth, my daughter in law told my son that he is an impotent (Nopunsak) and he is not able to give birth of a baby and the said son is his one of friend's, and after some days my family members accept the said relation as because the minor child and they both have started to came in my house frequently but they never reside in my house together. After some days my son told me that his mother in law namely Sulekha Poddar, his elder sister in law namely Sumi Poddar and his brother in law namely Sumit Poddar alongwith his wife torture upon my son by physically and mentally.

It is pertinent to mentioned here that, the wife of my son has maintained many relationship with so many unknown boyfriends which is also encourage by her mother, brother and sister and on one occasion the wife of my son caught red handed with a man of very compromise situation and whenever my son raised to protest, she alongwith her boyfriends beaten my son and for that my son got several injury on his different parts of body. And after sometime they both have started to reside at Fulbari, beside of Dreamland amusement park in the house of one Sikandar Das.

I would like to further inform you that, on 11.09.2022 I received a phone call from the landlord of my son and informed me that the health condition of my son is not well and on hearing the said condition I alongwith one relative namely Liton Sikdar (husband of my wife's sister's) rushed to the said house of Mr. Sikandar Das and found my son on unconsciousness condition and thereafter we took him with us at about 10 p.m. in my

residential house and I requested to his wife to came back in my house alongwith minor child. That seeing his ill heath I took my son to a nearby doctor and the doctor had

I would like to further inform you that, on 12.09.2022 at night my son felt pain in his stomach and I found his health condition going to be very serious and finding no other alternative I brought my son to the Maharaja Agarsen Hospital in the next mooring i.e., on the morning of 13.09,2022 and concerned doctor told me that the health condition of my son is very serious and he needs to be admit in ventilation as he has taken somekind of poison and has also been diagnosed with drug overdose. And the concerned doctor further stated me that the stomach of my son is loaded with full of blood and due to consuming some poison the condition of my son is detoriate. Thereafter I tried to contact with the wife of my son to know about the poison but she refused to talk with us and I came to know from the landlord of my son that on 09.09.2022 my son, his wife and one another unknown person consuming alcohol and on 13.09.2022 when my son got admitted in hospital she fled away with said unknown person alongwith the minor child.

I would like to further inform you that, thereafter due to shortage of fund I shifted my son to the Mitra's Nursing home and the present condition of my son is very serious and he may not alive due to consuming of poison, and it is my strongest believe that the wife of my son and his boyfriend intentionally doing this to kill my son and her family members are also involved with this happening.

I would like to request you to investigate the matter and do needful according to the law as because the concerned doctors have already told us that my son may not alive and now he is in coma, the culprit are require to punish.
