Sir 1 am Arnab Bhattacharjee to mention that my mother Dipali Bhattacharjee (Since deceased), wife of Late Sailen Bhattacharja died intestate on 05.01.2003 leaving behind her Son namely Sri Pallab Bhattacharjee and Sri Arnab Bhattacharjee as her legal heirs / successors according to Hindu Succession Act, 1956 are the absolute owner of a piece & parcel of land measuring 06 Kathas, situated with in Mouza Binnaguri, recorded in R.S. Khatiyan No. 746/9, in R.S. Plot Nos. 210 & 209 sheet No. 11 within specified boundaries by venture of Deed of sale on 15.02.1989 and transcribed in Book No1, volume No. 10, page 309 to 312, bring No. 1105 for the year 1989, registered in the office of

On 20th March 2017 when I Visited the above mention land the accused person along with some land brokers has illegally and forcefully entered into the said land. Were trying to demolish my boundary demarcation and constructing a concrete house on my land.

When I informed this matter to the New Jalpaiguri police Station, they immediately took action against Mr. Afas Ali and others and prevented them from that Construction. We also Sat together as per direction of the Police Station to solve the matter but nothing came out from it due to the non-co-operation on the part of the accused person.

There after, on 25th September 2017 When I visited the above mentioned land, the said Afas Ali along with some land brokers of the Said area rushed there and resist me to enter into my own land.

I had no other alternative way but to file F, I. R. against Afas Ali and Others on dated  $3^{rd}$  October 2017 .

I approached the local administration and police authorities several times who assured me that they were looking into the matter but as the time was passing away I got no relief.

On the contrary I gathered information on the first week of September, 2020 that they are representing themselves to be the owners of my said land and have circulated their desire to sell it and still now is Searching for prospective buyers. Now my prayers before you that the accused person should be ousted from my land. The main accused Afas Ali has entered into my land, illegally forcibly and in an unauthorized manner the Complainant is entitled to the restoration on the possession thereof after demolition of the hutment constructed by the accused person.

I hope you will pay adequate attention to the request and lodge this complaint to the FIR against Mr. Afas Ali and Others.
