1. Sl Pradeep Divali of New Jalpaiguri Police station, Siliguri Police Commissionerate do here by lodge this written complaint against above noted One (01) arrested accused person to the effect that today 19,09,2022 at about 1915 hrs I received a specific source input that One person were standing at Jatiyakali More with huge quantity of Contraband Drugs for delivering the same to their designed customers. The matter was diarized vide NJP PS PS GDE No. 917 Dt. 19.09,2022 and 1 informed the -matter to SI Partha Sarathi Das, Officer-In-Charge, New Jalpaiguri Police Station in writing a letter to him and expressed the entire information. As per his kind direction myself along with other officers and force named VP/13 Jamirul Islam, CV/306 Biswajit Roy and CV/824 Niru Kumar Yadav all of NJP PS, Siliguri Police Commissionerate being headed by me left for Jatiyakali More by govt, vehicle with investigation kit to verify the veracity of the information in hand vide NJP PS GDE No 918 dated 19.09.2022 and M.C.C. No. 1433/22 dated 19.09.2022. In the mean time I also informed the Videographer namely Tapan Mandal s/o Testo Mandal of Bhola More, PS- NJP, Dist.- Jalpaiguri to be present at Jaiyakali More to prepare the Video of whole process of search and seizure if any as well as informed Mobile Van officer who is detailed for Mobile Van vide New Jalpaiguri PS MCC No.- 1430/22 date: 19.09,2022 namely ASI Bhai Chandra Tamang to accompany us during the whole process of search and seizure if any. Under this circumstances any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidences of facility for the escape of the offender. At about 1955 hrs we arrived at Nipaniya near Jatiyakali More, in opposite side of Jatiyakali Nimna Bunyadi Primary School and on the way to the spot at Jiyaganj Petrolpum under New Jalpaiguri PS, SPC, I called two independent witnesses namely (i) Sukamal Sen Gupta s/o Lt. Subirsen Gupta of Shaktigarh Road No.- 03, PS- NJP, Dist.- Jalpaiguri (ii) Buddha Dev Saha s/o Arun Saha of Suryasen Colony, Bocl-A. Ward No.- 34, PS- NJP, Dist.- Jalpaiguri and disclosed our identity and informed them about the information in hand and requested them to accompany us and remain present in the whole process during search and seizure if necessary with a written letter and necessary permission of their presence and act as witnesses under relevant provision of law. After arrival at the spot and as identified by the source we found that 01 (one) person carrying black bag were standing at Nipaniya near Jatiyakali More, in opposite side of Jatiyakali Nimna Bunyadi Primary School, under PS- NJP, Dist.- Jalpaiguri which was matched with our information. Accordingly, we intercepted the above person who disclosed his identity as noted above.

After disclosing our identity, we detained the above noted person with a strong reason to believe that he illegally possessing Contraband Drug in his possession which he is carrying in his back for selling the same to their designed customers for his wrongful gain. On being asked he confessed that he possessed contraband Drug in his possession. I then gave him option in writing whether he wanted to be searched in presence of Executive Magistrate or by any Police Gazetted Officer. Then he agreed to be searched by any one of them. Further, I served him a notice in accordance with provisions of law in this regards. I also offered the independent witnesses and the apprehended persons to search our Police Party as per provesion of law but they denied to search police party. Accordingly, I informed the matter to the Officer In Charge, NJP PS, and as per his kind order Unformed the fact, to Sri Santanu Tarafdar, WBPS, Assistant Commissioner of Police, AP, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate, of SPC for the day regarding the interception of the accused person suspected to be possessed of Contraband Drug in his bag carrying by him and requested him to come to the spot and to supervise the search and seizure being a gazette officer. Accordingly at 2045 are seri santanu taraffar, Supervise the search and seizure being a gazent onicer, Accordingly in 2015 his ori Samuni Infantar, WBPS, Assistant Commissioner of Police. AP. Siliguri Police Commissionerate arrived at the spot and accordingly. I disclosed his identity to the detained persons as Special Executive Magistrate of Siliguri

Then in presence of Sri Santanu Tarafdar, WBPS, Assistant Commissioner of Police, AP, Siliguri Police Commissionerate detailed as Special Executive Magistrate and two independent public witnesses searched the detained person following all formalities and recovered (i) 10 (Ten) Packet of Nitrozepam Tablet IP style as Nitrosum 10 contains 05 strip in each packet [Total 10 X 05~50 Strip] marked Rupees-59.50 in each packet marked as Exhibit."A" and (ii) 33 (Thirty Three) bottle of Chlorphenire Makate & Codine Phosphate Syrup contain 100 ml in each bottle marked Rupees- 165.00 in each bottle marked as Exhibit. "B" which is kept in Black Color Bag style as Jansports. On demand in presence of the Sri Santanu Tarafdar, WBPS, Assistant Commissioner of Police, AP, Siliguri Police Commissionerate be failed to produce any valid document in support of possessing of Contraband Drugs which he is carrying as

Thereafter, in presence of Sri Santanu Tarafdar, WBPS, Assistant Commissioner of Police, AP, Siliguri Police Commissionerate and independent witnesses I took out the following samples (i) 01 (One) Stup of Nurozepam Tablet IP style as Nitrosun 10 taken as sample from Exhibit-"A" marked as Exhibit-"Al" (ii) 01 [One] Bottle of Chlorphenire Makate & Codine Phosphate Syrup contain 100 ml taken as sample from exhibit "B" marked as Exhibit "B1". Further, on demand in presence of Sri Santanu Tarafdar, WBPS, Assistant Commissioner of Police, AP, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate, of SPC for the day as well as independent witnesses the above noted detained persons tailed to produce any valid documents in support of possessing of contraband Drugs. Thus when his involvement in carrying and possessing Contraband Drugs was established, then I seized the above noted articles from the exclusive possession of the above noted accused persons at the spot at Nipaniya near Jatiyakali More, in opposite side of Jatiyakali Nimna Bunyadi Primary School, under PS- NJP, Dist.- Jalpaiguri under proper seizure list in presence of Sri Santanu Tarafdar, WBPS, Assistant Commissioner of Police, AP, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate, of SPC for the day as well as independent witnesses as noted above and acknowledged by the accused person. Subsequently. I labeled the seized articles in presence of Sri Santanu Tarafdar, WBPS, Assistant Commissioner of Police, AP, Siliguri Police Commissionerate and independent witnesses and accused persons as noted above. The whole process of seizure was made in between 2055 hrs. to 2145 hrs on 19.09,2022. On further asked he confessed in presence of Sri Santanu Tarafdar, WBPS, Assistant Commissioner of Police, AP, Siliguri Police Commissionerate acting as Special Executive Magistrate and other witnesses that he procured the Contraband Drugs clandestinely from Malda for the purpose of supply the same to their designed customers at Siliguri area as per their requirement for their personal gain by illegal means. On interrogation he also disclosed that he have been dealing in such business of selling of Contraband Drugs illegally for last few months.

From the above noted facts and seizure of incriminating articles it is quite evident that the accused persons namely Azizar Rahaman (52) s/o Lt. Saifuddin Rahaman of Ramichock, PO- Shersai, PS Kaliachock, Dist. Maldah is involved in procuring and selling of Contraband Drugs illegally and contravening the norms of NDPS Act, was established. Then, I arrested the above noted accused person after observing all guidelines of Apex court of arrest as well as after disclosing the cause of arrest and issued necessary Memo of Arrest. The whole process of seizure and arrest was made in-between 2055 hrs

Under the above noted facts and circumstances, I pray to you that a specific case under proper sections of law may kindly be started against the above noted arrested accused persons namely Azizar Rahaman (52) s/o Lt. Saifuddin Rahaman of Ramichock, PO- Shersai, PS- Kaliachock, Dist.-Maldah (Not verified) and arrange for its investigation.
