In producing herewith one female accused person named Boby Mahato (27) W/O Dipak Sarkar of Diesel Colony ,PS-Pradhannagar Dist-Darjeeling, along with the following seized articles:-

2. 17(Seventeen) bottles of Russell's premium whisky each bottle containing 750 ml. blended & bolted by Mayell & Fraser Pvt. Ltd. Bageykhola, Majhitar, Rangpo, Sikkim, India.

I. ASI Tarun Kanti Ghosh of Pradhannagar P.S under Siliguri Police Commissionerate do here by lodged a written complaint against Boby Mahato (27) W/O Dipak Sarkar of Diesel Colony ,PS- Pradhannagar Dist- Darjeeling,to the effect that today on 20.09.22 at '07.05 hrs. Received a specific input from the source that the above noted lady has kept huge numbers of illicit liquor in her petty shop at Cooliepara, Siliguri Junction in order to sale the same to her design customers without any valid license for wrongful gain. Accordingly the fact is diarized vide Pradhannagar, P.S. G.D.E. NO-1219 date 20.09.22, and informed the fact to you. As per your direction I along with CV/242 Rakesh Mongar CV 223 Swapan Chettri , L/C-744 Sarada Sarki left for Cooliepara, Siliguri Junction under Pradhannagar PS to verify the veracity of the information. On reaching there and as identified by source cordoned the petty shop where she kept illegal alcohol. On arriving there found the above noted person who disclosed her name & identity as noted above who kept the same at her shop in conceal position. On searching found 17(Seventeen) bottles of Russell's premium whisky each bottle containing 750 ml. blended & bolted by Mayell & Fraser Pvt. Ltd. Bageykhola, Majhitar, Rangpo, Sikkim, India .On being interrogation she could not produce any valid documents/license or authority in respect of the said illicit liquor. She also stated that she is doing this liquor business since last few months for her wrongful gain. Accordingly, I seized the same in presence of witness namely (1)Smt. Sangita Roy (36) W/O Anil Roy of Coolipara, Rajendra nagar, Dist. Darjeeling and (2)Smt. Khusbo Singh (25) W/O Raj Kumar Singh of Do as per proper seizer list duly signed by the witnesses. The seizure was made in between 07.35 hrs to 08.15 hrs. All the seized liquor are Sikkim made liquor. Following which West Bengal Government revenue has been lost. Apart from this local people are very much annoyed for selling the said illicit in said area. On being asked she stated that she kept the same with a view to sale and supply at Cooliepara area without any valid documents. As she has violated the rules and norms of Bengal Excise Act as such I arrested her with help of Lady constable after observing all sorts' arrest rules for selling the said illicit without valid license.

Therefore, I pray before your Ld Court that a specific case may kindly be started against accd. Boby Mahato (27) W/O Dipak Sarkar of Diesel Colony, PS- Pradhannagar Dist- Darjeeling, as per proper section of law.
