Darjeeling, has committed an offence by "directly connected the both phase & neutral from Bus Bar to meter (local company meter) having S/A no- 108394"

The Details are stated below:-

On 21.09.2022 at about 3.05 pm the undersigned alongwith (i) Ainal Kabir (J.E-II Shibmandir CCC) and (ii) Sri Sonam Sherpa, Sr. O.E & Sri Pravin Chettri, Sr. TSH have inspected the Block -Khushi of Smt Sauvika Mitra, D/o Dinesh Mitra, Utsab Phase-I Block- Khushi, flat no: C-7, P.O- Kadamtala, Dist. Darjeeling.

During inspection, it reveals that the person is using Electricity for the domestic purpose by directly connecting both phase & neutral from bus bar to meter (local company meter). The line is being disconnected on the spot and the "seizure list" and inspection report has been prepared and acknowledge to the Bapi Dey, representative from Utsab as a token receipt. The team left the premises at about 4.00 pm on 21.09.2022
