In producing herewith accused under arrest namely (1) Nasir Ali (33), S/o- Sakir Ali , (2) Nazir Ali (29), S/o- Sakir Ali, both of 41, Jatepur Utari, Kalimandir , Gorakhpur , UP-273015 and (3) Anand Bhagat(29), S/O-Prithbi Chand Bhagat of Sulochana Building, La-Den-La Road, PS-Sadar, Dist-Darjeeling on 22.09.22 in between 19:55 to 20:10 hrs arrested from 2C1, Barsana Apartments, PS Matigara, Siliguri Police Commissionerate, along with Seizure List, Memo Arrest, Check List and the seized articles and other documents, I Inspector Shyamal Ch.Das DDI -1, Darjeeling DD, CID, West Bengal, do here by lodged the complaint as SUO-MOTO to the effect that yesterday i.e. 21.09.2022 at about 12:20 hrs I received a credible information from my source to the effect that a few persons are running two Call Centres, styled as M/S Skylark Technology at Webel IT Park Phase I & III Siliguri and are cheating innocent customers abroad with huge amounts of money from them violating guidelines of Department of Telecommunication. They used to call innocent customers mainly from USA and Austraila, by introducing themselves as agents of different companies like Microtalk, Microsoft, Amazon etc. and spreading up internet etc, on the name of giving customer services and tech support. They were running this business by engaging vulnerable unemployed youth. I diaries the matter in G.D. Book (Vide Darjeeling DD, CID, West Bengal G.D. Entry No. 103 dated 21.09.22) and after consulting with the competent authority I worked out the information. Accordingly, after collecting sufficient information and in consultation with my superiors a plan was drafted which was diarised vide .G.D. Entry No. 107 Dated.21.09.2022. As per plan myself along with the detailed officers and force of Darjeeling DD vide CC.No. 44/22 dated.22.09.2022, left for SS (North) office, for attending the briefing of SS (North) CID, W.B. After completion of briefing I along with the above noted officers and force being accompanied by other members of the raiding party which included officers and force of SS (North) Office vide. CC No.31/2022 dated.22.09.2022,SPC CC.No.22.09.2022 (including lady constables) Jalpaiguri DD, CC.No 98/22 dated.22.09.2022, SI Barun Nayik of Cyber PS, Dakshin Dinjapur and source left SS(North) office for the raids at Barsana Apartments, under Matigara PS, SPC at 18: 10 hrs. along with kit box, video camera man, laptops, printer, hard discs and necessary investigation kits. As per the signal of the source and as per plan the arresting party entered the premises of 2C1, Barsana Apartments, PS Matigara, Siliguri Police Commissionerate, at about 18:30 hrs. and we found three persons in the flat.

Darjeeling for running the above noted call centers for cheating and misappropriating huge sums of money vulnerable foreign clients in the guise of acting as agents of reputed companies the and violating the guidelines provided by the Govt. Authority.
