l, ASI Manoj Kumar Roy of Pradhan Nagar Police Station, Siliguri Police Commissionerate do hereby lodged this written complaint against accused persons namely (i) Sufala Barman (29) W/O- Ranjan Barman of Shalmaran P.S-Sahebganj , Dist- Coochbehar and (2) Minati Barman (40) W/O- Late Pradip Barman of Shalmaran P.S- Sahebganj , Dist- Coochbehar (Not Verified) to the effect that today on 23/09/2022 at about 14:30 hrs.I received a specific source input that two lady are coming from Coochbehar with huge consignment of ganja in order to sale the same to their designed customers at Milon more area for their wrongful gain and they are waiting in front Mount view Restaurant near Tika Prasad Ghat , Milon More . The matter was diarized in Pradhan Nagar PS GDE No. 1438/22 Dt 23.09.2022 and subsequently, I informed the matter to the Inspector-in-Charge, Pradhan Nagar Police Station in written and being directed, myself along with ASI Ashit Singha, Lady Constable 744 Sharda Sarki C/-992 Majibur Rahaman, CV- 128 Ajoy Kumar Sahani , CV-242 Rakesh Manger all of Pradhan Nagar PS, SPC along with investigation kit left for Mount view Restaurant near Tika Prasad Ghat , Milon More under Pradhan Nagar PS by Govt. vehicle to verify the veracity of the information with investigation kits. This refers to Pradhan Nagar PS GDE No. 1439/22 Dt. 23.09.2022 and M.C.C No-1792/22 Date- 23.09.2022.

Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for

the concealment of evidence or facility for the escape of the offender.

On the way to Milon More near Tika Prasad Ghat in front of Mount view Restaurant under Pradhannagar P.S. I contacted with two persons namely (1) Pappu Yadav S/O- Brahama deb Prasad Yadav of Milon More , P.S-Pradhannaggar, Dist- Darjeeling and (2) Raju Basnet S/O- Late Dhan Bahadur Basnet of Kolabari, P.S- Pradhannagar Dist-Darjeeling and make them aware of the information in hand and requested them to act as witness if any search and seizure would be made necessary upon which they agreed. Thereafter we along with above noted independent witnesses arrived at Milon More near Tika Prasad Ghat in front of Mount view Restaurant under Pradhannagar P.S. at 15:05 hrs and subsequently being pointed by my source found two lady stood in front of Mount View Restaurant with bags and were gossiping each others. Immediately myself along with my team with help of Lady constable detained both the lady with a strong reason to believe that they are carrying huge consignment of Ganja. Thereafter we disclosed our identity and information in hand and stated them that they as well as the under their possession will be searched for the purpose. On being asked they disclosed their name and identity as noted above. Thereafter I gave them option in writing to be searched in presence of an Executive Magistrate or by any Gazetted Officer upon which they agreed to be searched in presence of any one of the above. I also offered the independent witnesses and the accused persons to search our Police Party as per provisions but, they did not search the police party. Consequently, I informed the matter to I/C Pradhan Nagar PS and as per his kind order, I informed the matter to Shri Asish Subba , Assistant Commissioner of Police, (Traffic, West Zone) Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate of SPC for the day, regarding the interception of the accused persons suspected to be possessed Ganja illegally and requested him to come at Milon More near Tika Prasad Ghat in front of Mount view Restaurant under Pradhan Nagar P.S to remain present and to supervise the search and seizure.

Accordingly at 15:45 hrs Shri Asish Subba , Assistant Commissioner of Police, (Traffic, West Zone) Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate of SPC arrived at Milon More near Tika Prasad Ghat in front of Mount view Restaurant under Pradhan Nagar PS as Special Executive Magistrate, SPC and in presence of two independent witnesses I searched the detained persons following all formalities, keeping their decency with the help of L/C-744 Sharda Sarki and recovered the above noted articles from their joint possession of the accused persons namely (i) Sufala Barman (29) W/O- Ranjan Barman of Shalmaran P.S- Sahebganj, Dist- Coochbehar and (2) Minati Barman

(40) W/O- Late Pradip Barman of Dharmendar of Shalmaran P.S- Sahebganj , Dist- Coochbehar.

Further, on demand in presence of Shri Asish Subba , Assistant Commissioner of Police, (Traffic, West Zone) Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate of SPC detained Lady namely (i) Sufala Barman (29) W/O- Ranjan Barman of Shalmaran P.S- Sahebganj , Dist- Coochbehar and (2) Minati Barman (40) W/O-Late Pradip Barman of Dharmendar of Shalmaran P.S- Sahebganj , Dist- Coochbeha failed to produce any valid documents/papers or explanation for possessing of such a huge consignment Said to be Ganja . I accordingly weighted

Thereafter, I seized above noted consignment said to be Ganja from their joint possession at the spot at Milon More near Tika Prasad Ghat in front of Mount view Restaurant under Pradhannagar P.S. under proper seizure list in presence of independent witnesses and Shri Asish Subba , Assistant Commissioner of Police, (Traffic, West Zone) Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate of SPC obtaining their signature and being acknowledged by the Lady accused persons. The whole process of search and seizure are made under close supervision of

Vediography as per provision of law.

Subsequently, I labelled and scaled the seized articles in presence of Shri Asish Subba , Assistant Commissioner of Police, (Traffie, West Zone) Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate of SPC and independent witnesses and the 02(Two) Lady accused persons namely ((i) Sufala Barman (29) W/O- Ranjan Barman of Shalmaran P.S- Sahebganj , Dist- Coochbehar and (2) Minati Barman (40) W/O- Late Pradip Barman of Shalmaran P.S-Sahebganj , Dist- Coochbehar. The whole process of seizure was made in between 16.05 hrs to 16.45 hrs.

Being further asked, the apprehended Lady accused persons namely ((i) Sufala Barman (29) W/O- Ranjan Barman of Shalmaran P.S- Sahebganj, Dist- Coochbehar and (2) Minati Barman (40) W/O- Late Pradip Barman of Shalmaran P.S-Sahebganj, Dist- Coochbehar. (Not Verified) admitted in presence of Shri Asish Subba, Assistant Commissioner of Police, (Traffic, West Zone) Siliguri Police Commissionerate and other independent witnesses that they have procured Ganja clandestinely for the purpose of selling the same in high rate to their designed customers for their personal gain by illegal means. They also disclosed that they have been dealing in this business of procuring and selling of said to be ganja illegally for last few months for their wrongful gain.

From the above noted facts and seizure of articles it is quite evident that the accused persons namely ((i) Sufala Barman (29) W/O- Ranjan Barman of Shalmaran P.S- Sahebganj , Dist- Coochbehar and (2) Minati Barman (40) W/O- Late Pradip Barman of Shalmaran P.S- Sahebganj , Dist- Coochbehar. (Not Verified) are involved in procuring and selling 'ganga illegally contravening the norms of NDPS Act. Thereafter, I arrested the above noted accused persons after observing all formalities keeping their decency with help of Lady constable and informing them ground of their arrest and issued necessary Memo of Arrest .

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused persons namely ((i) Sufala Barman (29) W/O- Ranjan Barman of Shalmaran P.S- Sahebganj, Dist-Coochbehar and (2) Minati Barman (40) W/O- Late Pradip Barman of Shalmaran P.S- Sahebganj, Dist-Coochbehar. (Not Verified) and arrange for its investigation.
