In producing herewith the arrested two (02) accused persons namely (i) Mofazzul Hossain (32) s/o Sultan Ali of Vill- Nabani, P.S- Dinhata, Dist.- Coach Behar (Not verified) and (ii) Biman Debnath (46) S/O Sunil Debnath of Ramkrishnapally, P.S- Kotwali, Dist. Coach Behar (Not verified) along with the following seized articles under proper seizure list:-

One blue colour hand bag containing total 40 (forty) numbers of blue colour plastic pouch [each containing two hundred pieces of said to be Yaba Tablet, total 8000 (eight thousands) J- and

One blue colour plastic pouch containing total two hundred pieces of said to be Yaba Table taken from 'Exhibit- A' and marked as 'Exhibit A-1'

Total 10 (ten) numbers of black colour plastic pouch each containing two hundred pieces of said to be Yaba Tablet and marked as Exhibit B (iv)

One black colour plastic pouch containing total two hundred pieces of said to be Yaba tablet taken from 'Exhibit B' and marked as 'Exhibit B-1'

One grey colour Maruti Suzuki Dzire vehicle having Reg. No. WB-06B-0262 (Sl no. 1 to Sl. No. IV kept inside Sl. No. V)

I, PSI Newton Biswas of New Jalpaiguri Police station, Siliguri Police Commissionerate do here by lodge this written complaint against above noted two (02) arrested accused persons to the effect that today 24.09.2022 at about 16.55 hrs I received a specific source input that two persons were coming from Coach behar side towards Siliguri with a grey colour Maruti Suzuki Dzire vehicle having Reg. No. WB-06B-0262 with huge quantity of Yaba tablet for delivering the same to their designed customers. The matter was diarized vide NJP PS GDE No. 1354 Dt. 24.09.2022 and I informed the matter to SI Partha Sarathi Das, Officer-In-Charge, New Jalpaiguri Police Station in writing a letter to him and expressed the entire information. As per his kind direction myself along with a joint raid team consisted with officers and forces of Detective Department and NJP P.S named ASI Sajal Das, VP/08 Laxman Roy, CV/116 Rohit Kumar Mahato all of NJP PS, Siliguri Police Commissionerate and SI Amartya Chakraborty, ASI Abu Taleb, ASI Proloy Bhattacharjee, ASI Ratan Pradhan, C/562 Utpal Saha, C/ 945 Krishna Barman and Constable- Driver/ 598 Shibu Das all of Detective department, Siliguri Police Commissionerate being headed by me left for Jatiyakali More by govt, vehicle with investigation kit to verify the veracity of the information in hand vide NJP PS GDE No 1355 dated 24.09:2022 and M.C.C. No. 1867/22 dated 24.09.2022. In the mean time I also informed the Videographer namely Tapan Mandal s/o Testo Mandal of Bhola More, PS- NJP, Dist.- Jalpaiguri to be present at Jaiyakali More to prepare the Video of whole process of search and seizure if any as well as informed Mobile Van officer who is detailed for Mobile Van SI Dipankar Chakraborty to accompany us during the whole process of search and seizure if any. Under this circumstances any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidences of facility for the escape of the offender. At about 17.35 hrs we arrived at Jatiyakali More and on the way to the spot under New Jalpaiguri PS, SPC, I called two independent witnesses namely (i) Anowar Ali (40) S/O Lt. Md. Mofijuddin of Vill- Jatiyakali, P.S- NJP, Dist.- Jalpaguri (ii) Mansur Ali (27) S/O Khalil Muhammad of Sat Pradhanpara, P.S- NJP, Dist.- Jalpaiguri and disclosed our identity and informed them about the information in hand and requested them to accompany us and remain present in the whole process during search and seizure if necessary with a written letter and necessary permission of their presence and act as witnesses under relevant provision of law. After arrival at the spot and we started looking for vehicle noted above and finally noticed that the above noted vehicle bearing registration No WB-06B-0262 is coming from Cooch Behar Side and proceeding towards Siliguri Side. We managed to detained the said vehicle at as identified by the source and found that two person was sitting in the grey colour Maruti Suzuki Dzire vehicle having Reg. No. WB 06B-0262. On being asked they disclosed their identity as (i) Mofazzul Hossain (32) s/o Sultan Ali of Vill- Nabani, P.S. Dinhata, Dist.- Coach Behar and (ii) Biman Debnath (46) S/O Sunil Debnath of Ramkrishnapally, P.S. Kotwali, Dist.- Coach Behar. The above noted Mofazzul Hossain was found at driver seat and the above noted Biman Debnath was found beside driver's seat. On ground of suspicion we found one blue colour hanbag in between drivers seat and left side front seat of the said vehicle,
