Sir,

With due respect, I am producing herewith one arrested accused person namely Dashrath Saha (44) s/o Lt. Ram Chandra Saha of Haripur, Gwalapatty, PS- NJP, Dist.- Jalpaiguri under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

1. 15 (fifteen) bottles of Himalayan Gold 60 UP Country Spirit each bottle containing 600 ML.

1. ASI Sajal Das presently attached with NJP PS under your kind control beg to state that today i.e. on 24.09.2022 at 2215 hrs I received a secret source information that one person namely Dashrath Saha (44) s/o Lt. Ram Chandra Saha of Haripur, Gwalapatty, PS- NJP, Dist.- Jalpaiguri is selling ID liquor illegally at his resident located at Haripur, Gwalapatty, PS- NJP, Dist.- Jalpaiguri. Accordingly, I diarized the fact in the General diary vide NJP PS GDE No. 1373 dated 24.09.2022 and informed the fact to you. As per your kind direction and instruction myself along with CV/824 Niru Kumar Yadav, CV/306 Biswajit Roy all of NJP PS, SPC left for Haripur, Gwalapatty, PS- NJP, Dist.- Jalpaiguri to work out the information in hand. At about 2235 hrs we arrived at haripur Gwalapatty, PS- NJP, Dist.- Jalpaiguri and being identified by the source I found the said accused person selling Illegal Distilled liquor to his regular customer at his Shop situated at Haripur, Gwalapatty, and as per the indication of source managed to apprehended him. During interrogation he disclosed his identity as noted above and also disclosed that he is selling ID liquor at his Shop at Haripur, Gwalapatty, under NJP P.S since long for his illegal gain. On search the above noted I/D liquor recovered from his possession. On demand he failed to produce any documents/licence in respect of store/sale the I/D liquor recovered from the his possession. Accordingly, I seized the above noted I/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search & seizure was made in between 2245 hrs to 2315 hrs

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Dashrath Saha (44) s/o Lt. Ram Chandra Saha of Haripur, Gwalapatty, PS- NJP, Dist.- Jalpaiguri and arrange for its investigation.
