**Sub:- Written Complaint**

Sir,

I, Roushan Aara, Daughter of Anwarul Haque, Aged about 27 years, Resident of Utpal Nagar, Ward No. 43, near Children Park, Champasari, District- Darjeeling, do hereby lodge this complaint to the following effects that today at about 6:50 P.M. while I was coming to the chamber by Scooty slowly in crowded road then one person was driving the one four wheeler vehicle bearing No. WB-72-R 9257 at nearby Champasari more before NH 31, and suddenly stopped his vehicle. I wanted to overtake the said vehicle on my own way then the said driver of the Vehicle got down from the car and started shouting on me without any reason and claiming that why are you trying to over take me and I politely submitted to him that I did not obstruct you but I wanted to go to my chamber without causing any harm to you.

Then he used slang languages by saying like *Jhaat ki beti* etc for the two times in front of the public standing over the road. He was trying to come close to me and asked him to stay away from me but he did not stop and I just wanted to save myself from him but he did not stop but he came more closer to me and all of a sudden he wanted to attack directly on my face and I just tried to save myself by my right hand and my right hand got injured, thereafter the passersby of the road saved me from him and then I asked him to disclose his name then he said that you can get my name and other details from the Bahan App, I found that the name of registered owner is Amit Dey. After some time my hand started pain and there after my friend came and took me at Siliguri Sub-Divisional Hospital and I took treatment therefrom.

I request you to take appropriate legal action against the culprit who assaulted to me and tried to outrage my modesty in front of the public and also for using abusive and slang languages.
