Sir,

I, Mahendra Kumar Baid, Proprietor of Madan Trading Co., registered office address at 228, Sevoke Road, Siliguri, District- Darjeeling would like to inform you that SRH INFRASTRUCTURE, represented by its proprietor Sonu Gupta, having registered office at Mohit Nagar, District- Jalpaiguri, have placed an order of welding machine, glass cutting torch, industrial oxygen regulator and other goods amounting to Rs. 43,862/- (Rupees Forty Three Thousand Eight Hundred and Sixty Two Only) inclusive of taxes. That on February, 2019 Sonu Gupta and his father namely, Radhashyam Gupta, approached me in my office in the aforesaid address and induced me to sell the goods to them on credit and persuaded me to believe that their firm holds a good reputation and they have made many transactions with the sellers in Siliguri and have referred few names from Siliguri and also handed over to me a post-dated cheque dated 20.02.2019 amounting to Rs. 43,862/- of Axis Bank Ltd, Jalpaiguri Branch, being cheque no. 250586 assuring me about encashment of the cheque and prompt payment. They made me to believe in their credentials and believing them, I agreed to supply goods to him on credit basis. That accordingly, I raised challan and invoice vide invoice no. MTC/399/18-19 dated 15/2/2019 of Rs. 43,862/. That the goods were duly delivered to Sonu Gupta and Radhashyam Gupta.

That after two days Sonu Gupta called me up over phone and requested me not to drop the aforesaid cheque and requested for time and thereafter on May, 2019 after informing Sonu Gupta I dropped the aforesaid cheque on 6th May, 2019. However the same got bounced and my banker informed me about the same that the cheque did not get encashed on account of "funds insufficient". That I immediately informed about this to Sonu Gupta and Radhashyam Gupta. But they kept on taking time on one or the other pretext and subsequently there was lockdown and ultimately on 23rd September, 2022 I called Sonu Gupta in his mobile number 7001224831 and asked him to make the payment. But he refused to make the payment of Rs. 43,862/- and also used abusive language against me and told me not to call him again. I was shocked to hear this and so I called Radhashyam Gupta over phone in his number 7718783005 but he did not responded to my call.

Therefore, today on 27th September 2022 I sent my staff namely, Amit Roy Chowdhury in the office of Sonu Gupta and Radhashyam Gupta at Jalpaiguri to collect the payment. But they misbehaved with my staff and slapped him, pulled his collar and warned him of dire consequences if he comes there again to ask for payment.
