 13(Thirteen) sealed bottles of Himalayan Gold 60 up PET Country Spirit each bottle containing 600 ml.

I, ASI, Jamirul Haque of Ambari Falakata Out Post under NJP PS/SPC lodged a written complainant against the above noted accused person to the effect that today on 26.09.2022 at about 15:40 hrs received source information that one person has gathered huge amount of liquor illegally and selling the same to the local customer at Farabari, Velkipara for his wrongful gain. This refers to Ambari Falakata out Post GDE No. 888, Dated 26.09.2022. Therefore, I conveyed the same to O/C Ambari Falakata Out Post and as per his instruction I along with 1) ASI. Rabi Tamang (2) HG / 1158 Niten Roy (3) VP-14 Paritosh Roy, (4) CV-01 Jaychand Roy all of Ambari-Falakata OP, Under NJP PS/SPC proceed to Farabari, Velkipara to work out veracity of the information. At about 16.20 hrs we have reached at the spot and being identified by the source our police party held raid at Farabari, Velkipara, in presence of two independent witnesses namely 1) Abhijit Majumder S/o. Lt. Ashim Majumder of Chakiavita, PO. Kamarvita, PS-NIP Dist-Jalpaiguri and 2] Subash Sarkar S/o Lt. Narayan Sarkar of 09 No Colony, Ambari-Falakta, PO. Kamarvita, PS-NJP Dist-Jalpaiguri and recovered (i) 13(Thirteen) sealed bottles of Himalayan Gold 60 up PET Country Spirit each bottle containing 600 ml. from the possession of accused person namely Anil Adhikary (50yrs), S/o. Lt. Dhenial Adhikary of Farabari, Velkipara, P.O. Sahudangi Hat, PS-NJP, Dist-Jaipangura On being demand he could not produce any valid license/documents in support of said liquor. He become nervous and admitted his guilt below us and stated that he sells the same to the local villagers since long for his veroagital gain Accordingly, I have seized the above noted articles under proper seizure list in presence of above noted witnesses and took signature of the accused person and witnesses. The seizure was made in between 16:25 hrs to 16:45 hrs. Therefore, I have arrested the said accused u/s 41 Cr.P.C. and issued Memo of arrest appraising the ground of arrest in presence of witnesses.

I therefore request you that a specific case may kindly be started against the accused person namely Anil Adhikary (50yrs), S/o. Lt. Dhemal Adhikary of Farabari, Velkipara, P.O-Sahudangi Hat, PS-NJP, Dist-Jalpaiguri under proper section of law.
