With due respect I am producing herewith one accused namely Bishnu Gurung (34years) S/O Lt Bijoy Gurung of Bandrijote ,Dagapur,P.S-Pradhannagar, Dist.Darjeeling along with one seized truck bearing registration No- NL 08A 3824 loaded with river bed materials (Sand Stones)

I SI Sibdhan Karmakar of Pradhannagar P.S. under Siliguri Police Commissionerate do hereby lodged this written complaint against Bishnu Gurung (34years) S/O Lt Bijoy Gurung of Bandrijote ,Dagapur,P.S-Pradhannagar, Dist.Darjeeling to the effect that today on 10.10.2022 while performing mobile van duty along with C/762 Mojibar Rahaman CV/128 Ajay Kr Sahani ,CV/223 Swapan Chettri, CV/242 Rakesh Mongar all of Pradhannagar PS , vide Pradhannagar P.S GDE No- 498 date 10.10.2022. In course of mobile duty at Dagapur at 15.15 hrs at that time I received a reliable source information that a truck bearing registration No- NL 08A 3824 loaded with river bed materials was coming from Panchanai River side at Bandrijote ,Dagapur,P.S-Pradhannagar,Dist.Darjeeling in order to clandestinely dispose the said articles to his customers . As such myself along with force left for Bandrijote to verify the veracity of the information . After reaching at Bandrijote I found that one truck bearing registration No- NL 08A 3824 was coming from through Panchanai towards Dagapur . I tried to stop the said truck but the driver of the vehicle did not pay heed my words . After hot chased, we managed to detain the said truck bearing reg no NL 08A 3824 along with owner of vehicle. On being asked he disclosed his name and identity noted above , but the driver of vehicle namely Uday Munda S/O Not Known of Bandrijote ,P.S- Pradhannagar,Dist.Darjeeling somehow fled way from the truck .Thereafter I searched the said truck and found that the truck was loaded with river bed materials (sand stone) . On interrogation detained owner of the vehicle stated that he along with driver carrying the RBM without any documents from Panchanoi River for selling the same in high price for their wrongful gain. Accordingly, I seized the truck along with River bed materials and also prepared a seizure list duly signed by the local witnesses . Seizure was made in between 16.15 hrs to 16.55 hrs .and arrested the above noted accused person after observing all sorts of arrest rules. .

During preliminary enquiry it could be learnt that the alleged persons are carrying river bed materials illegally in regular basis by illegal means for their wrongful gain. Following which Government has been suffering huge amount revenue for their illegal act .

Therefore, I pray before you that a specific case under proper section of Law may kindly be started against the above noted accused persons named Bishnu Gurung (34years) S/O Lt Bijoy Gurung of Bandrijote ,Dagapur,P.S-Pradhannagar, Dist. Darjeeling (owner of vehicle) and Uday Munda S/O Not Known of Bandrijote ,P.S- Pradhannagar,Dist.Darjeeling (Driver of the vehicle) and arrange for its investigation
