This is to inform you that Mr. Wasi Aktar Shah of Kurseong, Ward number 7, Near Chandan Nursery, PO & PS Kurseong, District Darjeeling, Pin 734203 forcibly occupied 4 kathas of land inside our complex illegally on the basis of forged documents which has got no validity. We have locked our gate 3 times on the gate of this illegally occupied land, but every time after 10:00 PM at night his care taker comes and breaks our locks and enter inside the premises. In the morning the care taker goes out from the said premises leaving his wife and one child inside the gate. Yesterday i.e. on 13/10/2022 also we have fixed up new locks on the gates in the morning after they break our lock after 10:00 PM by the care taker on 12/10/2022. Today i.e. on 14/10/2022 we have also send our representative to fix up new locks on the same gate which was broken on 13/10/2022 by the same care taker after 10:00 PM at night.

In this connection we would like to intimate you that One Shri Laldeb Rai who is staying at the side of Devenport Tea Warehouse towards our complex always obstructing to fix up locks on the same gate explaining that he works on behalf of Rajak Group. It is to be mentioned here that Shri Laldeb Rai (M): +91 76796 49214 is a criminal and was arrested in other cases and kept in Jail Custody for One month approximately against whom a case may also be started for obstructing our operations to lock the gate and day to day business from the said complex.

Now, we would like to mention here that we have filed a Title Suit No.249 dated 5th of September 2022 in the Junior Division, Civil judge, Siliguri for cancellation of the forged deeds and injunction thereof occupied by Wasi Aktar Shah of Kurseong for 4 kathas of Land whose proper address was mentioned above.
