I am Pushpa Sah W/o Dr. Ramesh Sah, National Vice Chairman, International Human Rights and Anti Crime Organization Head Quarter Samar Nagar Colony Champasari, Police Station-Pradhan Nagar. I would like to inform you that my daughter Madhu sah got married to Manoj Gupta on 20 November 2021, the eldest son of Shri Ramnath Gupta, resident of Salugara Dimdima Basti, according to social and Hindu customs. Two lakh ten thousand in cash as a Gifted to the daughter-in-law, a gold chain of fifteen grams, a gold ring of five grams, and a gold necklace of twenty grams for the daughter, ear earrings gold of five grams, (two sets) silver anklets (two sets) and all household items were provided. Son-in-law Manoj Gupta s/o Ramnath Gupta, Mother-in-law Munia Gupta w/o Ramnath Gupta, and Married Sister-in-law Mala Gupta w/o Sonu Gupta, Pradhan Nagar Siliguri and Sister-in-law Sarita Gupta w/o Jeet Prasad, Samar Nagar Colony, Champasari together these four torture my daughter mentally and physically.

These people always tell my daughter that you are not beautiful, Manoj (son) was not lucky enough that he got married with you and your parents have given nothing to us, bring money from your maternal home, then stay in this house or else go home. Samdhi Ramnath remains a watcher and didn't support my daughter. When me and my husband Dr. Ramesh Sah went to meet our daughter, the daughter's father-in-law goes out of the house, when we come back home, they torture my daughter and say that why are your parents came here and ask your parents not to come here next time or else face the dire consequences. Last date on 11/6/2022 some fruit were sent in the hands of my younger daughter Ekta shah for the daughter as she was seven month pregnant then. They abused and insulted my younger daughter a lot and threatened not to come here again.

On July 10, 2022, son-in-law Manoj Gupta called and said that you guys do not come to my house, there is tension going on in my house. If you come you will face dire consequences. Still we went to meet the daughter on 11/7/2022. We were prevented from entering the house. We called the Panchayat Samiti member Kavita Chhetri there and then we were allowed to meet the daughter in the verandah. After some time, both the daughter of Samdhi reached there and the younger daughter Mala Gupta started abusing in abusive language and pushed us out and her husband Mr. Sonu Gupta started making videos from mobile.

On last 25/10/2022, my daughter gave birth to a son by operation in Shanti Nursing Home located on Sevoke Road right now my daughter is in in-laws' house and is not safe. In such a situation, her in-laws are not taking care of her properly and are torturing her mentally. We want to take care of the daughter by bringing her home, but the in-laws are not letting our daughter come to our house. On 13/10/22, at around two o'clock, my husband Dr. Ramesh Sah had gone

to in laws house with Harendra Sah and Vinod Singh of Dimdima Basti to bring our daughter home but they refused to let her go and also abused him.

On the same day on 13/10/2022 at 7 pm my daughter called us and said that I am not feeling well in my in-laws' house. I heard these people saying among themselves that these people will throw me out by keeping the child with them. My daughter is feeling insecure at her in-laws' house our daughter life is in danger we fear that this people can even get my daughter killed or disappeared. My Daughter wants to come home. We cannot go alone to fetch the daughter because the in-laws of the daughter can implicate us in a false case.

Therefore, the police administration is requested to cooperate with us in bringing my daughter home from her in-laws house.
