In producing herewith One(01) arrested accused person namely Dipankar Sarkar (29) S/O-Budhishwar Sarkar of 538 Singimari, P.O-Notun Bosh, P.S-Setai, Dist-Coochbehar (not verified) along with the following seized articles under seizure as per seizure list:

i) One Pink Colour Nylon Bag containing 6.395 Kg said to be "Ganja" and marked as Exhibit- A,

ii) One Transparent packet containing 100gm said to be "Ganja" taken as sample from Exhibit A and marked as Exhibit\_A-1.

iii) One violet Colour Nylon Bag Containing 6.780 Kg said to be "Ganja" and marked as Exhibit- B.

iv) One Transparent packet containing 100gm said to be "Ganja" taken as sample from Exhibit B and marked as Exhibit\_B-1.

I, SI Rantu Haldar of Bhaktinagar Police Station, Siliguri Police Commissionerate do here by lodge this written complaint against above noted person to the effect that on today on 14.10.2022 at about 19:25 hrs. received a specific source input that one person is coming from Coochbehar by bus with two travel bags contained Ganja ready for supplying the said consignment of ganja to his designed customers for his wrongful gain at PC Mittal Bus Terminus under PS- Bhaktinagar. The matter was diarized vide Bhaktinagar PS GDE No. 645 Dt- 14.10.2022 Accordingly, I informed the matter to the I/C Bhaktinagar PS/SPC in writing a letter to him and expressed the entire information. As per his kind direction myself along with SI Sajal Roy, PSI Chiranjit Saha, ASI Dipak Karmakar, Const- 1431 Dilip Barman, CV/014 Labanyamay Barman, all of Bhaktinagar PS, Siliguri Police Commissionerate left for PC Mittal Bus Terminus under PS- Bhaktinagar by Govt vehicle to verify the veracity of the information vide GDE NO 646/22 SPC M C C. NO.1465 Dt. 14.10.2022

At the time of departure from office I took envelope, white paper, sealing wax, gum, seal, Digital weighing machine (Certified by the weight and Metallurgy department) etc. At about 19.55 hrs we arrived at Siliguri PC Mittal Bus Terminus under PS- Bhaktinagar and called two independent witnesses namely (a) Gosai Sarkar (34) S/O- Santosh Sarkar of Jurapani, Jurapani, P.S- Dhupguri, Dist-Jalpaiguri A/P Jaleshwari Bazar, P.S- NJP, Dist-Jalpaiguri and (b) Subhash Biswas (45) S/O- Lt Anil Biswas of Sarajini pally, Prakash nagar, W.No- 42, P.S- Bhaktinagar, Dist- Jalpaiguri who were present there and disclosed our identity and informed them about the information in hand and requested them to accompany us in the whole process during search and seizure if necessary with a written

letter and necessary permission of their presence and as witnesses of entire process under relevant provision of law. As identified by the source we found that one person who is standing in the main gate of PC Mittal Bus Terminus under PS- Bhaktinagar which matched with the information in which two travel bag i,e one pink and another one violet colour travel bag both were carrying by hand. Accordingly on being asked of the apprehended person he disclosed his identity as noted above. After disclosing our identity, we detained the above noted person with strong reason to believe that he has illegally possessing ganja inside his bag, which he was carrying for supplying the same to his designed customers for his wrongful gain. On being asked he confessed that he has possessed ganja in his bags for supplying the same to his designed customers as per requirement and he waiting there for transportation same. I then gave him option whether he wanted to be searched in presence of the Executive Magistrate or by any Gazetted Officer. Then he agreed to be searched by one of them. Further I served him a notice in accordance with provisions of law in this regards. I also offered the independent witnesses and the accused person to search our Police Party as per provision. But they refused to search the police party. Then I sent ASI Dipak Karmakar with a requisition to Special Executive Magistrate Shree Suraj Thakuri ACP (HQ) SPC for supervise the hole processes of search and seizure. At 20.45 hrs ASI Dipak Karmakar returned at the spot with Shree Suraj Thakuri ACP (HQ) SPC in uniform and disclosed his identity to the detained person as well as witnesses as Special Executive Magistrate, Shree Suraj Thakuri ACP (HQ) SPC. Under supervision of Shree Suraj Thakuri ACP (HQ) SPC and in presence of two independent public witnesses searched was conducted of the detained person following all formalities keeping his decency but nothing could be recovered from his physical possession except wearing apparels. Then conducted search the bag which he was carrying by hand and found the above noted seized articles which was kept inside the said bag. On demand in presence of the Special Executive Magistrate, Shree Suraj Thakuri ACP (HQ) he failed to produce any valid document in support of possessing of the ganja which was kept inside his bag.

Accordingly I weighted the Ganja by the weighing instrument of Bhaktinagar PS SPC and found total 13 kg 175 grams of said to be ganja in 02 Packets which are kept in two bags and marked as Exhibit- A, Exhibit- B, I also labeled and sealed all the article in presence of the Special Executive Magistrate, Shree Suraj Thakuri ACP (HQ) SPC and independent witnesses and accused person. I then seized the above noted articles under proper seizure list and label duly signed by the above noted witnesses and the Special Executive Magistrate, Shree Suraj Thakuri ACP (HQ)SPC and acknowledged by the accused person. The seizure was made between 21.25 hrs to 22.35 hrs. On further interrogation the apprehend person confessed in presence of Special Executive Magistrate, Shree Suraj Thakuri ACP (HQ)SPC and other witnesses that he procured the seized Ganja clandestinely from elsewhere for the purpose of selling the same in high rate to his designed customers for his personal gain by illegal means. On interrogation he disclosed that he has been dealing in such business of selling the ganja illegally for last one year Then I arrested the above noted accused person after observing all guidelines of Apex court as well as after disclosing the cause of arrest and issued necessary Memo of Arrest. Thus arrested accused
