In producing herewith three arrested accused persons named (1) Md. Chottu @ Langra (29) S/O Lt. Md Amiruddin of Tulshi Nagar, Kholai Busty, PS- Matigara, Dist-Darjeeling 2) Md Jakir @ Captain (25) S/O Lt. Jabed Ali of Tikiapara, Matangini II, Ward No 28, PS- Siliguri, Dist-Darjeeling (3) Md Maksud (35) S/O Abdul Hakim of Maker, PS- Maker, Dist- Chapra(Bihar) along with seized articles (i) one knife measuring 13" including handle wrapped from the possession of Md. Chottu @ Langra (29) S/O Lt. Md Amiruddin which was kept concealed on the back side waist 2) One iron sword measuring 31" including iron handle recovered from the possession of Md Jakir @ Captain (25) S/O Lt. Jabed Ali which he was holding on his hand 3) One iron rod measuring approx 25" pointed one end recovered from the possession of Md Maksud (35) S/O Abdul Hakim which he was holding on his hand under proper seizure list.

I, SI Dilip Kr. Das of Khalpara TOP Under Siliguri PS/ SPC do here by lodge this written complaint to the effect that on 17.10.22 at 00.15 hrs I received secret source information that 7-8 persons had assembled at Kishore Math, Ward No 04 to commit dacoity at the locality. Immediately informed the tip of information to O/C Khalpara TOP and as per his kind direction I, noted the fact in GD book vide Khalpara TOP GDE No 350 dated 17.10.2012 and as per his kind instruction myself along with SI Ashim Kr. Das ASI Uttam Kr. Dhar, ASI Samiran Das, C/239 Badal Kr. Barman, C/1048 Gopal Roy, C/174 Pradip Kr Das, C/516 Sunil Roy, CV-916 Amresh Sah left for Kishore Sangha Math, Ward No 04 to verify the veracity of the information. At about 00.45 hrs I along with police party arrived at the spot Kishore Sangha Math, Ward No 04 and after keeping our vehicle at a distant place we proceeded towards Kishore Sangha Math on foot and being indicated by the source found from the considerable distance that a gang of seven/eight persons were assembled at Kishore Sangha Math and they were whispering in very low voice. Accordingly, we cordoned the place properly and approach towards them. But seeing the presence of police party, they scattered in multi direction and started fleeing away but after a hot chase manage to apprehended (03) persons and others persons fled away from the spot. On interrogation, the apprehended persons disclosed their name, address as noted above, and started giving incoherent statement regarding their presence/gathering in the same place also. On further grilling they stated that they along with others assembled there in preparation to commit docaity. Accordingly on being search I recovered one knife measuring 13" including handle wrapped from the possession of Md. Chottu @ Langra (29) S/O Lt. Md Amiruddin which was kept concealed on the back side waist 2) One iron sword measuring 31" including iron handle recovered from the possession of Md Jakir @ Captain (25) S/O Lt. Jabed Ali which he was holding on his hand 3) One iron rod measuring approx 25" pointed one end recovered from the possession of Md Maksud (35) S/O Abdul Hakim which he was holding on his hand. Accordingly, I seized the above noted recovered articles as per seizure list in presence of witnesses and duly singed by them in between 01:15 hrs to 01:45 hrs and I arrested them U/S 41 Cr.P.C. after explaining the charges against them.

Under the above fact and circumstances I pray that a specific case may kindly be started against (1) Md. Chottu @ Langra (29) S/O Lt. Md Amiruddin of Tulshi Nagar, Kholai Busty, PS- Matigara, Dist-Darjeeling (2) Md Jakir @ Captain (25) S/O Lt. Jabed Ali of Tikiapara, Matangini II, Ward No 28, PS-Siliguri, Dist-Darjeeling (3) Md Maksud (35) S/O Abdul Hakim of Maker, PS- Maker, Dist- Chapra (Bihar) and others under proper Section of law.
