I, Miss. Molina Akther D/o Nasir Uddin presently resident of Anchal Bazar, Iskon Mandir Road PS Bhaktinagar, Dist: Jalpaiguri permanent resident of Debpur, PS Beldanga, Dist: Murshidabad, PIN 742134. I beg to state that on 12.09.2022. I had visited Dr. Amit Biswas for treatment as I was not feeling well to his chamber near Ullka Club Ground. While check up I noticed and felt his bad intention but ignored all these keeping in mind his profession and reputation but-

After that visit he started talking to me over cell phone for general health enquiry. Then he started calling and messaging me frequently from his cell phone which number is 8617804187 and he also meet with me while I was at cosmos mall once and started pressurising me to meet him personally in some lonely area. All these massages are in record. But I completely refused his proposal and ask him not to bother me further. But he did not stop calling me over telephone repeatedly and started giving me the proposal for marriage with him which I denied again.

Now he started threatening and blackmailing me in different ways and expressed that he would go to any extent to spoil my reputation and assassinate my character or face dire consequences if I don't except his proposals which includes sharing bed with him.

He is continuously harassing me and made my life miserable and feeling insecure as I am single lady reside alone in a rented house.

Now I am feeling very much insecure as well as afraid too thinking so that he may harm me physically at any time or may kill me. I am very much scared and passing time with very much anxiety in such an atmosphere.

I therefore would like to request you to kindly, help me and take every necessary action against Dr. Amit Biswas as per provision of law.
