Sir,

In producing herewith one accused person namely (1) Biswajit Roy (22) S/O Late Giren Roy of Jaleshwari bazaar PO Sahudangi PS Bhaktinagar Dist. Jalpaiguri and the following articles under seizure:

- (1) 12 (Twelve) bottles of "HIMALAYAN GOLD PREMIUM 60 UP COUNTRY SPIRIT" each bottle containing 600 ML, MRP Rs.120/- (Total-7.2 Liter & Amount Rs 1440/-)

I ASI Amit Mallick of Ashighar OP PS Bhaktinagar lodged a written complaint against the accused person namely (1) Biswajit Roy (22) S/O Late Giren Roy of Jaleshwari bazaar PO Sahudangi PS Bhaktinagar Dist. Jalpaiguri to the effect that, today i.e 16.10.2022 evening as per order of O/C Ashighar OP I along with ASI Prahlad Singha C/ 877 Munia Ahmed and CV/1016 Amrit Roy, all of Ashighar OP with Govt. vehicle no WB42/R 8829 were holding raid against anti social elements, warrentees, ID liquor etc in different area under Ashighar OP as per order vide Ashighar OP GDE no. 487 Dt 16.10.2022, in course of which I received information from my source that one Biswajit Roy storage huge numbers of bottles of liquor inside his house at Jaleshwari bazaar and used to sell to the local youth in higher rates. I immediately informed O/C Ashighar OP and as per his kind direction wasting no time I along with my accompanied party left for Jaleshwari bazaar area to verify the veracity of information. On the way I called two local person namely (1) Sujit Roy (37) S/O Late Satish Roy of Ashighar Colony PS Bhaktinagar Dist. Jalpaiguri and (2) Ajay Sarkar (31) S/O Sunil Sarkar of Niranjana nagar W/no. 36 PS Bhaktinagar Dist. Jalpaiguri to accompany us to witness the search and seizure if required. On reaching at Jaleshwari bazaar area as indicated by my source I held raid at the house of Biswajit Roy at Jaleshwari bazaar. But seeing us the above noted accused person tried to flee away from the spot, but we managed to apprehend him. I searched in the house of above noted accused person, in course of which I recovered the above noted bottles of liquor from inside his house. I seized the above noted articles as alamath of the case, as the above noted person as well as none could be able to produce any documents for such illegal possession of such articles. I also arrest the above noted accused person for violating the provision of B.E Act. The Search and seizure and arrest were made in between 21.25 hrs and 21.45 hrs on 16.10.2022

Under the above circumstances, I pray to you that a specific case may kindly be started against the accused person namely (1) Biswajit Roy (22) S/O Late Giren Roy of Jaleshwari bazaar PO Sahudangi PS Bhaktinagar Dist. Jalpaiguri and arrange for its investigation.
