This is with reference to my previous complaint dt.05th September 2020, 13th September 2020, 19th February 2021, 22nd February 2021, 26th February 2021,04th March 2021, 20th May 2021, 14th September 2021 and 03rd May 2022 stating that some Local miscreants and land mafias namely Mr. Laltu Yadav and his associates have forcefully encroached into my property situated at Plot No.52,53, JL No. 107, Khaitan No.24, Mouza Mandalaguri, Pokaijote, Champasari, Siliguri.

I am the absolute and exclusive owner of the land measuring about 15 Kathas at Mouza- Mandlaguri, Police Station- Pradhan Nagar, District- Darjeeling, which I had purchased in the year 2005 vide a registered deed being no. I-497 for the year 2006 and since then I had been peacefully using, enjoying and occupying the said land until the month of September, 2020 when Laltu Yadav, a noted miscreant of the locality, broke open my 20.10.22 Or 19.07 padlocks installed in the main gate of my land and attempted to encroach upon the said land along with his other antisocial associates.
