

l ASI Manoj Kr Roy of Pradhannagar PS, SPC would like to lodge this written complainant against the above noted accused person to the effect that today on 20.10.22 in course spl mobile van duty at PS area with force CV/646 Baban Das ,CV/992 Jagadish Biswas vide PDN PS GDE NO 1124 dtd.20.10.22 at 20.05 hrs ,I received an information that the one person namely Upendar Ray is storing and selling liquor illegally in his Hotel style as Mala Hotel at Baghajotin Colony ,near Circuit House under Pradhannagar PS .Accordingly, I share the information to you and as per your kind instruction myself along with force rush to the spot and as pointed by the source we apprehended the above noted person and search his shop recovered above noted articles .On interrogation he admitted that selling the same illegally without obtaining valid document for his illegal gain. Accordingly, I seized & label the above noted articles in between 21.15 hrs to 21.45 hrs and I arrested him.

Therefore, I request you to start a specific case under proper section of law against the arrested person namely Upendar Ray (35) S/O Lt Bhutan Ray of Baghajotin Colony ,near Circuit House ,P.S-Pradhannagar , Dist. Darjeeling and arrange for its investigation.
