In producing herewith one accused person namely Sanjib Talukdigur (Relica Commissionerali Subal Talukdar of Tiranga More, Patiram Jote, PS- Matigara, Dist.- Darjeeling under arrest and following seized articles under seizure-

- 1) 18 (Eighteen) big packets of JUGMUG CHOCOLATE JUNIOR (Sound Crackers) each packet containing 06 (Six) small packets i,e total (18 x 6) 108 Packets and each packet containing 12 pcs i,e total (108 x 12) = 1296 pcs weighing total 7.2 kgs.
- 100 (One hundred) packets of SV King Kobra Electric Crackers (Sound crackers) weighing total 4.3 kgs.

I, PSI Shekhar Adhikary of Matigara Police Station, Siliguri Police Commissionerate do hereby lodged this written complaint against the above mentioned accused person namely Sanjib Talukdar (43 yrs) S/O Late Subal Talukdar of Tiranga More, Patiram Jote, PS- Matigara, Dist.-Darjeeling to the effect that today on 19.10.2021 at 19.35 hrs received a secret information that one Sanjib Talukdar of Tiranga More, Patiram Jote, has stored huge quantity of Fire-crackers at his shop styled as Talukdar verity Store situated at Tiranga More, Patiram Jote for selling the same in the open market for his wrongful gain without having any license or other valid documents in respect of the same, violating the provision of law which may endanger human life and likely to cause injury of human life. Accordingly, I diarized the fact in General Diary vide Matigara PS GDE No 932 dated 19.10.22 and informed the fact to the O/C, Matigara PS. As per your kind order I along with ASI Tapan Das, C/974 Mintu Sen, C/374 Debraj Biswas and others all of Matigara PS, SPC rushed to the spot at Tiranga More, Potiramjote to work out the information in hand. After arrival at Tiranga More, Potiramjote I contacted with my source and being identified by the source, I held raid at Talukdar verity Store situated at Tiranga More, Patiram Jote under PS Matigara, Dist.- Darjeeling and managed to apprehended the owner of the said shop. On being asked he disclosed his identity as noted above. On search the above noted illegal fire crackers recovered from his possession. On interrogation admitted his guilt. Further, on demand he failed to produce any valid documents / license in support of the possession of such quantity of Fire crackers recovered from his shop. There is a reason to believe that accused Sanjib Talukdar (43 yrs) S/O Late Subal Talukdar of Tiranga More, Patiram Jote, PS- Matigara, Dist.- Darjeeling has stored the said consignment of fire crackers for selling the same in the open market for his wrongful gain, which are combustible in nature and endanger to human life. Moreover, the above noted fire crackers were stored without any precautionary and safety measures.

Accordingly, I seized the above noted fire crackers under proper seizure list duly signed by the witnesses and acknowledged by the accused person namely Sanjib Talukdar (43 yrs) 8/0 Late Subal Talukdar of Tiranga More, Patiram Jote, PS- Matigara, Dist.- Darjeeling. The whole process of seizure was made between 20.15 hrs to 21.05 hrs. Subsequently, I arrested the above noted accused person namely Sanjib Talukdar (43 yrs) S/O Late Subal Talukdar of Tiranga More, Patiram Jote, PS- Matigara, Dist.- Darjeeling observing all the formalities and informing the ground of his arrest.

Under the above fact and circumstance, I pray before you that a specific case may kindly be started against the accused person namely Sanjib Talukdar (43 yrs) S/O Late Subal Talukdar of Tiranga More, Patiram Jote, PS- Matigara, Dist.- Darjeeling under proper section of law and arrange for its investigation.
