**ILLEGAL CONSTRUCTION ON DEFENCE ESTABLISHMENT**

1. During routine recce of def land on 10 Oct 2022, an illegal attempt for construction within 100M of defence land (photos attached) by an indl named Mr Ganesh Sunar, Vill – Batla Bari, Bagdogra, Dist - Darjeeling was noticed within 100 mtrs near defence land boundary wall which is in complete violation of orders of Government of India, Ministry of Defence letter No 11026/2/2011/D(Lands) dt 18 May 2011 and Headquarters Eastern Command letter No 305150/17/P/Q3 dt 06 Feb 2019 (copy attached).
2. The unit recce team has instructed the indl to immediately remove the illegal construction.
3. In view of the above, you are requested to take suitable legal action against the owner on the above issue without further delay.
4. Please lodge an FIR immediately.
